## President's Message

Brothers and Sisters,

THIS COULD BE CONSIDERED A RE PRINT OF A MESSAGE I WROTE ABOUT TWO YEARS AGO IN REGARD TO THIS RIDICULOUS BANTER ABOUT MANDATORY HELMET LAWS. FIRST OF ALL I THINK BY NOW WE SHOULD PROBABLY HAVE HEARD THE LAST OF THIS CRAP, AT LEAST IN FLORIDA. I DON'T BELIEVE ANYBODY REALLY HAS ACCURATE STATISTICS ON ACCIDENTS INVOLVING MOTORCYCLES. PEOPLE CAN, (AND DO) PLAY WITH PERCENTAGES TO PROVE THEIR POINT ALL DAY LONG AND THE RESULTS WILL STILL REMAIN INCONCLUSIVE. THAT GOES FOR PROPONENTS AND OPPONENTS OF "HELMET OR NO HELMET". WHAT I STAND FIRM ON IS THAT THE GOVERNMENT FROM STATE LEVEL TO THE FEDERAL LEVEL HAVE NO CONSTITUTIONAL RIGHT TO IMPOSE LAWS THAT DISCRIMINATE AGAINST ANY ONE GROUP OF PEOPLE. IF THE STATES OR THE FED'S WOULD PASS A LAW REQUIRING THAT ALL PANTS MUST BE WORN ABOVE THE HIPS BECAUSE THEY APPEAR TO BE A SAFETY CONCERN, YOU'D HAVE AL SHARPTON, JESSY JACKSON AND PROBABLY A SLEW OF OTHER MINORITY COMMUNITY LEADERS AND THE A.C.L.U. SCREAMING BLOODY MURDER.

I WISH I WOULD HAVE PAID MORE ATTENTION TO THE MEDIA REPORTS OF ACCIDENTS INVOLVING MOTORCYCLES, PRIOR TO THE HELMET LAWS BEING REPEALED. BEING AN AVID VIEWER CNN AND THE FOX NETWORK I ALSO SCANNED NEWSPAPERS DAILY AND I DON'T REMEMBER SEEING ANY MEDIA REPORTS OF MOTORCYCLE ACCIDENTS WITH THE EXCEPTION OF AN OCCASIONAL "CELEBRITY INJURED IN MOTORCYCLE ACCIDENT" BUT I REALLY DON'T REMEMBER ANY OTHERS. I GUESS BACK THEN IT DIDN'T MATTER SO MUCH THAT A MOTORCYCLIST GOT KILLED WE WERE, AFTER ALL WEARING HELMETS. THERE WAS NO CONTROVERSY, NOBODY DID ANY STUDIES, I GUESS NOBODY INCLUDING THE INSURANCE COMPANIES REALLY GAVE A SHIT. EVER SINCE JULY OF 2000 IT HAS BECOME A MEDIA OBSESSION TO REPORT IN EVERY MOTORCYCLE RELATED INCIDENT WITH WHETHER THE RIDER WAS OR WASN'T WEARING A HELMET. SUDDENLY EVERYBODY, THE NTSB, NHTSA, THE INSURANCE INDUSTRY POLITICIANS, EVERYONE IS SO CONCERNED ABOUT MOTORCYCLISTS. THERE HAVE BEEN STUDY AFTER STUDY DONE, ALL KINDS OF STATISTICS COMING FROM BOTH SIDES AND THEY STILL HAVE NOT BEEN ABLE TO COME TO A REASONABLE UNDERSTANDING OF *WHY* THESE ACCIDENTS HAPPEN.

WOULDN'T IT BE BETTER TIME SPENT COMING UP WITH AN EDUCATIONAL PROGRAM TO PREVENT ACCIDENTS FROM HAPPENING THAN SCREWING AROUND WITH STATISTICS THAT MEAN NOTHING AND DO NOTHING TO REDUCE THE AVERAGE OF INCIDENCE? IF THERE WERE REALISTIC PERCENTAGES AND STATISTICS AVAILABLE, MY GUESS IS THERE WOULD BE A MUCH HIGHER PERCENTAGE OF MOTORISTS INJURED OR KILLED THEN MOTORCYCLISTS. WHY WOULD I SAY

THAT? WELL BECAUSE THERE ARE MORE CARS, TRUCKS, SUV'S AND MINI VANS ON THE ROAD THEN EVER BEFORE. MORE VEHICLES, A HIGHER PERCENTAGE OF ACCIDENTS THE SAME IS TRUE WHEN YOU CONSIDER THAT THERE ARE MORE MOTORCYCLISTS ON THE ROAD. NOW IF YOU ADD IN THE OFF ROAD VEHICLES THE PERCENTAGE BECOMES EVEN HIGHER. BUT THE DIFFERENCE IS THAT THE OFF ROAD MOTORCYCLES ARE NOT ON THE ROAD WHICH IS WHY THEY ARE REFERRED TO AS OFF ROAD VEHICLES. IF YOU COMBINE THOSE NUMBERS OF OFF ROAD VEHICLES WITH THE NUMBERS OF MOTORCYCLES ON THE ROAD IT PAINTS A COMPLETELY DIFFERENT PICTURE TO ANYONE NOT REALIZING THESE NUMBERS HAVE BEEN COMBINED. THEN YOU COMBINE INJURY AND FATALITY NUMBERS OF RIDERS WEARING HELMETS WITH THE RIDERS NOT WEARING HELMETS AND NO DISTINCTION BETWEEN ON ROAD AND OFF ROAD MOTORCYCLES AND YOU HAVE A VERY DISTORTED AND LOPSIDED VIEW OF WHAT THE REAL STATISTICS SHOW. THAT WITH THE BIASED AND IRRESPONSIBLE MEDIA REPORTING OF ACCIDENTS INVOLVING MOTORCYCLES AND YOU HAVE LAW MAKERS AND THE GENERAL PUBLIC VOTING FOR THINGS THAT THEY KNOW NOTHING ABOUT.

IT'S CALLED MANIPULATION, TO TAKE IT TO THE NEXT LEVEL WE NOW HAVE POLITICIANS AND STATE REPRESENTATIVES WHO ARE WILLING TO HAND ALL THIS OVER TO THE FEDERAL GOVERNMENT WHO THREATEN TO WITHHOLD FUNDING TO THOSE STATES WHO WISH TO DRAW THEIR OWN CONCLUSIONS AND UPHOLD THEIR CURRENT LAWS AND CHOOSE TO MAKE THEIR OWN DECISIONS. THAT'S CALLED EXTORTION. FUNDING FOR WHAT? BETTER HIGHWAYS AND SAFER ROADWAYS. NOW THERE'S A PLAN! THAT'S CALLED STUPIDITY.

WHY WOULD ANYONE VOTE FOR A PERSON WILLING TO TURN THEIR HEAD TO YOUR WISHES FOR THE SAKE OF GAINING "POPULAR OPINION" AMONG THEIR PEERS. IF ANYONE BELIEVES THESE PEOPLE YOU THINK YOU CAN IDENTIFY WITH ARE EVEN REMOTELY CONCERNED WITH WHAT *YOU* THINK OR WHAT YOU ARE CONCERNED WITH. YOU CAN REST ASSURED, THEY DON'T. MONEY, POWER, VOTES AND CONTROL IS WHAT MATTERS TO THEM. AND THEY'D SELL US OUT AT ANYTIME TO SUIT THEIR OWN AMBITIONS. AS WAS DEMONSTRATED BY GOOD OL' MEL MARTINEZ WHEN THE VOTE WAS TAKEN A YEAR AGO ON A FEDERAL MANDATORY HELMET LAW WAS PROPOSED BY SEN. LAUDENBURG, OF NEW JERSEY. FORTUNATELY SENATOR NELSON HUNG IN THERE WITH US. THE RESPONSE FROM ABATE AND OTHER MRO'S NATIONWIDE KNOCKED DOWN THAT BILL BUT LIKE MANY OTHERS I KNEW WE HADN'T HEARD THE LAST OF THAT.

MUCH WORSE IS, YOU HAVE NO SAY IN IT, BECAUSE IT'S BEING VOTED ON BY OUR STATE REPRESENTATIVES WHO REALLY COULDN'T CARE LESS ABOUT THE REALITY OF WHAT WE ARE SAYING AND BECAUSE INSTEAD OF TALKING TO US, THEY'RE TALKING TO SOMEONE ELSE WHO DOESN'T HAVE A CLUE.

WE NEED TO LET THESE REPRESENTATIVES KNOW THAT IF THEY ARE REALLY GENUINELY INTERESTED IN OUR WELL BEING INSTEAD OF WASTING THEIR TIME AND ENERGY ON WRITING AND RE WRITING LEGISLATION ON MANDATORY HELMET LAWS, INSTEAD OF DWELLING ON PROTECTIVE APPAREL THEY SHOULD FOCUS ON WHAT MAKES RIDING A MOTORCYCLE DANGEROUS AND ALLOW THOSE WHO RIDE DECIDE ON WHAT SAFETY EQUIPMENT WORKS FOR THEM.

VEHICLES VIOLATING ANOTHER VEHICLES RIGHT OF WAY IS STILL THE NUMBER ONE KILLER OF MOTORCYCLISTS, TIME WOULD BE BETTER SPENT ON LEGISLATION FOR HIGHER MONETARY PENALTIES TO INCLUDE LICENSE SUSPENSION AND JAIL TIME FOR INJURING A MOTORCYCLIST AND VEHICULAR MANSLAUGHTER CHARGES FOR KILLING A MOTORIST OR MOTORCYCLIST. ENFORCING CURRENT LAWS WOULD DEFINITELY HAVE AN EFFECT ON ROAD SAFETY. HELMETS CANNOT PREVENT ACCIDENTS, AND IN MOST CASES MAKE NO DIFFERENCE ESPECIALLY IN THIS KIND OF ACCIDENT.

TALKING ON CELL PHONES AND OTHER DISTRACTIONS CONTRIBUTE TO THE DANGER. A TOTAL BAN OF CELL PHONE BLUE TOOTH ALL OTHER PHONE DEVICES INCLUDING HANDS FREE WOULD BE A GREAT FEDERAL MANDATE CONSIDERING IT HAS BECOME A NATIONAL EPIDEMIC. NOW WE CAN INCLUDE TEXT MESSAGING IN THAT AS WELL.

MANDATORY DRIVERS EDUCATION FOR SCHOOLS WOULD MAKE ANOTHER GREAT FEDERAL MANDATE. DRIVER'S EDUCATION IN FLORIDA SUCKS; AND FROM WHAT I'VE SEEN WE'RE NOT ALONE. DRIVER'S TESTS ARE GIVEN IN FOREIGN LANGUAGES AND SHOULD ONLY BE GIVEN IN ENGLISH ONLY. DRIVER'S TESTS ARE GIVEN IN A PARKING LOT INSTEAD OF ON THE ROAD, CREATING YET ANOTHER HAZARD BECAUSE NOW YOU HAVE PEOPLE WITH MINIMAL TO NO DRIVER SKILLS AND THEY CAN'T READ TRAFFIC SIGNS. IF THEY INSIST ON MAKING A FEDERAL MANDATES, TRY STARTING WITH FEDERAL MANDATORY LAWS FOR DRIVER'S EDUCATION IN SCHOOLS AND ADULT DRIVER EDUCATION COURSES FOR REPEAT TRAFFIC OFFENDERS AND LEGAL IMMIGRANTS WITH VISA'S AND PROPER DOCUMENTATION ONLY.

INSURANCE COMPANIES USE THE RISING HOSPITAL COSTS AND HEALTH AND MEDICAL CARE ISSUE FOR THEIR ROLL IN TRYING SAVING US FROM OURSELVES. BULLSH#T, THE REASON FOR THE RISING HOSPITAL COSTS AND MEDICAL AND HEALTH CARE IS BECAUSE THE FEDERAL GOVERNMENT IS GIVING IT AWAY TO ILLEGAL ALIENS AND THIRD AND FORTH GENERATION WELFARE RECIPIENTS. THE PERCENTAGE OF MOTORCYCLISTS IS SO MINUTE IN COMPARISON HOW COULD ANYONE CALCULATE WHAT EFFECT IT HAS HAD ON THE RISING COST FOR HOSPITALS AND HEALTH CARE.

WE CANNOT ALLOW THE FEDERAL GOVERNMENT TO CONTROL THE INDIVIDUAL STATES VOICE WHEN IT COMES TO REPRESENTING THE VOICE OF IT'S PEOPLE. IF THE STATE

REPRESENTATIVES REFUSE TO HEAR THE VOICE OF THE PEOPLE WHO ELECTED THEM THEY'VE BEEN SOLD OUT, THOSE THAT VOTED AGAINST THEM WILL HAVE TO SUFFER RIGHT ALONG WITH THEM BECAUSE OF A BAD DECISION. THOSE ELECTED REPRESENTATIVES NEED TO BE EDUCATED BEFORE THEY VOTE IN OUR BEHALF. IF YOU'RE A REGISTERED VOTER YOU HAVE AN OPPORTUNITY TO CONTACT THOSE IN YOUR DISTRICT TO PASS ALONG INFORMATION THEY MAY NOT RECEIVE FROM ANYONE ELSE. THEY WILL LISTEN, YOU VOTE. NON- REGISTERED VOTER'S YOU CAN THEIR PART BY CIRCULATING INFORMATION IN YOUR COMMUNITIES. WE MUST NOT ALLOW THE RIGHTS OF INDIVIDUAL STATES TO BE GIVEN AWAY BY THE IRRESPONSIBLE ACTIONS OF LAZY ELECTED REPRESENTATIVES.

**You may know us as the motorcycle organization that got the helmet law repealed in Florida or from our motorcycle rights and safety rally's throughout the year. ABATE of Florida is not a club, we are a motorcycle rights & safety organization dedicated to promoting motorcycle safety while remaining ever vigilant of the legislative issues concerning motorcyclists' nationwide.**

**THERE ARE NO MANDATORY REQUIREMENTS**

Because we are not a club there are no mandatory rides or meetings to attend. We do not require our members to wear our patch. If you are currently a member of a motorcycle club or any other motorcycle association or organization we welcome your support as a member.

**YOUR COLORS OR PATCH ARE ALWAYS WELCOME IN OUR HOUSE**

Our most recent victories include the passing of Bill HB1697 requiring stiffer penalties for a motorist turning left in front of another motorist, one of the leading causes of injury and death to motorcyclist'. A reformed bill regarding "Ape Hangers" has also been passed, handlebars are now to be measured from the riders shoulders rather than the seat. We also helped beat down legislation proposed by Senator Frank Lautenberg (D-NJ) on an amendment to the transportation, reauthorization bill (SAFE-TEA) that would re-institute a federal helmet law for all riders by denying federal transportation and safety dollars to that state

**WE ARE NOT ANTI-HELMET, WE ARE ANTI-HELMET LAW**

One of the most popular misconceptions about ABATE is that we are anti-helmet. Nothing could be further from the truth. We are "anti-helmet law" if you chose to ride with or without a helmet it's your choice, it is your right to decide whether wearing a helmet is right for you. ABATE is an organization fighting to protect your rights.

There are over 7,000 members of ABATE in the state of Florida with over 30 active chapters. We feel Palm Beach County has huge potential in becoming one of the largest chapters in the state. 

## Vice President's Message

BACK IN 1972, LONG BEFORE I WAS LIVING IN FLORIDA, I WAS RIDING DOWN HERE WITH 2 FRIENDS FOR A VACATION. WE MADE THE MISTAKE OF STARTING OUR DRIVE FROM NEW YORK EARLY ON THE SATURDAY MORNING OF JULY 4<sup>TH</sup> WEEKEND. AS YOU CAN IMAGINE THERE WERE SEVERAL AREAS WHERE WE HIT BUMPER-TO-BUMPER TRAFFIC AND CRAWLED ALONG. I WAS DRIVING A CANDY-APPLE RED 1971, PLYMOUTH ROADRUNNER, DECKED OUT WITH CRAIGER CHROME MAG WHEELS A BLACKED OUT HOOD SCOOP AND SPORTING A 440 MAGNUM ENGINE WITH TWO HOLLY 650 CARBS. JUST WHAT YOU'D EXPECT A 20 YEAR OLD COP TO BE DRIVING!

AS YOU MIGHT IMAGINE, FROM ALL THE SLOW DRIVING IN TRAFFIC AND REMEMBERING THAT I95 WAS BARELY 50% COMPLETED BACK THEN AND A LOT OF OUR 1500 MILE TRIP WAS ON SURFACE ROADS, WHEN I HAD A OPEN STRETCH OF HIGHWAY I PUSHED THE SPEED LIMITS A BIT. VERY EARLY SUNDAY MORNING, INTO OUR TRIP ABOUT 24 HOURS STRAIGHT BY THEN, I TOOK THE WHEEL AGAIN FROM MY FRIEND AND FIRED THE ROADRUNNER TO ITS LIMIT RATHER THAN THE POSTED SPEED LIMIT. AS FATE WOULD HAVE IT I CHOSE THE WRONG STRETCH OF ROAD AND MANAGED TO PASS TWO SOUTH CAROLINA STATE TROOPERS WORKING RADAR. TO MAKE A LONGER STORY SHORTER, EVEN THOUGH I WAS A "YANKEE PO-LICE OFFICER" 142MPH IN A POSTED 70MPH ZONE WAS TOO MUCH FOR A "PROFESSIONAL COURTESY" AND I GOT THE TICKET. I "POSTED BAIL" IN THE AMOUNT OF \$15 AND WAS BACK IN MY WAY TO FLORIDA; FOLLOWED FOR THE NEXT AND LAST 15 MILES OF SOUTH CAROLINA BY THE TWO STATE TROOPERS, NEEDLESSLY TO SAY AT EXACTLY THE SPEED LIMIT.

MY PURPOSE FOR RELATING THIS STORY IS TO SAY THAT IN LOOKING BACK AT THE WAY I DROVE WHEN I WAS YOUNGER, I EVEN STARTLE MYSELF WITH MANS INERT STUPIDITY THAT IS CONNECTED TO INEXPERIENCED YOUTH. BUT THAT STUPIDITY, AS EXAMPLED BY MY STORY, IS DEFINITELY NOT LIMITED TO MOTORCYCLES. THAT'S RIGHT! THIS BILL PROPOSES THAT A POLICE OFFICER; "SHALL ARREST THE PERSON, TAKE HIM OR HER INTO CUSTODY, AND SEIZE THE MOTORCYCLE". IF THIS IS NOT DISCRIMINATION I DO NOT KNOW WHAT IS!

I HAVE GOTTEN E-MAILS FROM OUR STATE PRESIDENT DOC REICHENBACH AND LEGISLATIVE TRUSTEE JEFF BAXLA WHO ADVISED ME THAT WE ARE GOING TO FIGHT THIS BILL, BUT WE NEED ALL OF OUR MEMBERS TO HELP BY CONTACTING THEIR REPRESENTATIVES AND ADVISING THEM OF THE TOTAL DISCRIMINATORY NATURE OF THIS PROPOSED BILL. PLEASE CHECK OUT OUR WEB SITE FOR THE CONTACT INFORMATION FOR YOUR REPRESENTATIVES.

BROTHERS AND SISTERS WE SAY OVER AND OVER AGAIN THAT IT IS FAR BETTER TO EDUCATE THAN LEGISLATE AND HERE IS A PERFECT EXAMPLE. WOULDN'T IT BE MUCH MORE EFFECTIVE TO SPEND THE MONEY IN

OUR FLORIDA BUDGET ON EDUCATING THE YOUNG MEN AND WOMEN WHO ARE DRIVING IN THESE CARS AND RIDING THESE POWERFUL, LIGHT SPORTS BIKES? I SAY LET'S SPEND OUR MONEY TO SAVE THEIR LIVES BEFORE THEY DO SOMETHING STUPID AS I DID! I WAS LUCKY; I DIDN'T KILL MY SELF OR INJURE SOMEONE ELSE. LET'S GET OUR ELECTED OFFICIALS ON OUR SIDE BY INFORMING THEM WE WANT THEM TO BACK PROPOSED LEGISLATION THAT WILL EDUCATE RATHER THAN LEGISLATION THAT DISCRIMINATES AND PUNISHES.

BELOW IS AN EXCERPT OF THE BILL.

### FLORIDA HOUSE OF REPRESENTATIVES

A BILL TO BE ENTITLED:

AN ACT RELATING TO OFFENSES COMMITTED WHILE OPERATING A **MOTORCYCLE**; CREATING S. 316.1926, F.S.; PROVIDING ADDITIONAL PENALTIES FOR CERTAIN OFFENSES COMMITTED BY A PERSON OPERATING OR IN ACTUAL PHYSICAL CONTROL OF A **MOTORCYCLE**; REQUIRING THAT THE PERSON BE TAKEN INTO CUSTODY; PROVIDING FOR SEIZURE AND FORFEITURE OF THE **MOTORCYCLE**; PROVIDING FOR REVOCATION OF THE PERSON'S PRIVILEGE TO OPERATE A **MOTORCYCLE**; PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF FLORIDA: SECTION 1. SECTION 316.1926, FLORIDA STATUTES, IS CREATED TO READ 316.1926 **MOTORCYCLE OFFENSES**.--

(1) WHEN A LAW ENFORCEMENT OFFICER CHARGES A PERSON WITH RECKLESS DRIVING IN VIOLATION OF S. 16.192 OR EXCEEDING THE SPEED LIMIT BY 30 MILES PER HOUR OR MORE IN VIOLATION OF S. 316.183(2), S. 316.187, OR S. 316.189 WHILE OPERATING OR IN ACTUAL PHYSICAL CONTROL OF A **MOTORCYCLE**, THE OFFICER SHALL ARREST THE PERSON, TAKE HIM OR HER INTO CUSTODY, AND SEIZE THE **MOTORCYCLE**, WHICH SHALL BE SUBJECT TO FORFEITURE UNDER THE FLORIDA CONTRABAND FORFEITURE ACT.

(2) **UPON CONVICTION, IN ADDITION TO ANY OTHER PENALTY PROVIDED BY LAW, THE COURT SHALL REVOKE THE PERSON'S AUTHORIZATION AND PRIVILEGE TO OPERATE A MOTORCYCLE FOR A PERIOD OF 10 YEARS AND ORDER THE PERSON TO SURRENDER HIS OR HER DRIVER'S LICENSE.**





**NTSB MISSES THE MARK** THE NATIONAL COALITION OF MOTORCYCLISTS (NCOM) JOINS THE GROWING CHORUS OF MOTORCYCLISTS RIGHTS ORGANIZATIONS NATIONWIDE THAT TAKE ISSUE WITH RECENT RECOMMENDATIONS BY THE NATIONAL TRANSPORTATION SAFETY BOARD THAT STATES ENACT MANDATORY HELMET LAWS, AND HAS RELEASED THE FOLLOWING STATEMENT FROM JAMES D. "DOC" REICHENBACH II, CHAIRMAN OF THE NCOM BOARD OF DIRECTORS:

"MOTORCYCLE DEATHS IN THIS COUNTRY ARE CERTAINLY REACHING EPIDEMIC PROPORTIONS. BUT WITHOUT CONDUCTING A THOROUGH INVESTIGATION, THE NTSB'S CLAIM SEEMS TO BE IT IS THE MOTORCYCLISTS' FAULT. IS IT THE MOTORCYCLIST'S FAULT THAT THEY CHOOSE NOT TO WEAR HELMETS AND THAT LARGER VEHICLES RUN OVER THEM?

IN 2004 LOUISIANA REINSTATED THEIR MANDATORY HELMET LAW. IN 2006 THE DEATHS JUMPED ALMOST 20%. THE PROJECTION THIS YEAR IS IT WILL JUMP MORE THAN 10% AGAIN, REACHING RECORD NUMBERS. IN FLORIDA SINCE THE HELMET LAW WAS AMENDED THE FATALITY RATE FOR HELMET-WEARING RIDERS HAS FAR EXCEEDED THAT OF NON-HELMET RIDERS. IN FACT, IN EVERY INJURY CATEGORY HELMETED RIDERS ARE SUFFERING MORE INJURIES AND DEATHS THAN HELMETLESS RIDERS. IN 2005 MORE THAN 59% OF THE MOTORCYCLIST DEATHS IN FLORIDA WERE HELMETED RIDERS. SINCE 2000 THE MOTORCYCLE REGISTRATIONS HAVE INCREASED MORE THAN 160%. TO BELIEVE THERE IS NO CORRELATION BETWEEN THE INCREASE OF REGISTRATIONS AND THE INCREASE IN DEATHS IS JUST STICKING YOUR HEAD IN THE SAND. IN OTHER WORDS THE NTSB THINKS MOTORCYCLISTS SHOULD BE FORCED BY LAW TO WEAR A HELMET EVEN THOUGH HELMETED RIDERS REPRESENT 3 OUT OF 5 FATALITIES.

AS FAR AS THE MOTORCYCLE RIDERS COSTING THE TAXPAYERS MONEY, NCOM CERTAINLY DOES NOT AGREE WITH THE STATEMENT TO CNN ABOUT OUR CHILDREN'S HEALTH, NOR DO OUR MORE THAN 1,000 NCOM MEMBER GROUPS ACROSS THE COUNTRY. WHAT WE ARE CONCERNED WITH IS THE IDEA THAT MOTORCYCLISTS ARE BEING NEGLECTED AS TAXPAYERS AND CITIZENS. WE ARE FATHERS, MOTHERS, SONS AND DAUGHTERS. WE ARE YOUR NEXT-DOOR NEIGHBORS AND THE VETERANS WHO RISKED THEIR LIVES TO PROTECT THIS COUNTRY IN TIME OF WAR. ARE WE TO LOSE OUR RIGHTS BECAUSE THE NTSB HAS NOT DONE THEIR JOB OF GATHERING INFORMATION AND INSTEAD JUST MAKES BLANKET STATEMENTS? THE NTSB SHOULD ENCOURAGE MOTORCYCLE TRAINING AND EDUCATE THE NON-RIDING PUBLIC THAT MOTORCYCLES ARE OUT THERE SHARING THE ROAD."

**"SUPERSPORT" MOTORCYCLES UNDER FIRE FROM INSURANCE INSTITUTE** A RECENT MEDIA BLITZ BY THE INSURANCE INSTITUTE FOR HIGHWAY SAFETY, AN INSURANCE INDUSTRY TRADE GROUP, PURPORTS THAT SO-CALLED "SUPERSPORT" MOTORCYCLES ARE NEARLY FOUR TIMES DEADLIER THAN ALL OTHER TYPES OF BIKES AND HAVE THE WORST OVERALL INSURANCE LOSSES.

THE IIHS STUDY, WHICH BASICALLY REVIEWS EXISTING FEDERAL FARS (FATAL ACCIDENT REPORTING SYSTEM) DATA AND CALCULATES MOTORCYCLE FATALITIES BY TYPE OF MOTORCYCLE, BLAMES THE GROWING POPULARITY OF RACING PLATFORM CYCLES AMONGST YOUNGER RIDERS IN PART FOR A DRAMATIC INCREASE IN U.S. MOTORCYCLE DEATHS, ACCORDING TO A SEPTEMBER 11 ARTICLE IN USA TODAY.

MOTORCYCLE FATALITIES JUMPED 59% FROM 2000-2005, WHILE OVERALL U.S. MOTORCYCLE REGISTRATIONS CLIMBED 51%, BUT SUPERSPORT REGISTRATIONS WERE UP 83% AND ACCOUNTED FOR 28% OF MOTORCYCLE FATALITIES WHILE REPRESENTING ABOUT 9% OF REGISTERED MOTORCYCLES. SO, WHILE OVERALL FATALITIES PER 10,000 REGISTERED MOTORCYCLES WENT UP FROM 7.1 IN 2000 TO 7.5 IN 2005, SUPERSPORTS WERE CREDITED WITH 22.5 DEATHS PER 10,000 REGISTRATIONS.

THE "SPORT AND UNCLAD SPORT BIKES" CATEGORY OF MOTORCYCLES, ALSO NOTED FOR THEIR SPEED AND AGILITY, POSTED A FATALITY RATE OF 10.7 PER 10,000, WHILE "TOURING" MOTORCYCLES WERE 6.5 AND "CRUISERS AND STANDARD MOTORCYCLES", WHICH COMPRISE THE BULK OF MOTORCYCLE REGISTRATIONS, WERE STATISTICALLY UNDER-REPRESENTED AT 5.7 FATALITIES/10M.

THE STUDY CRITICIZES MANUFACTURERS FOR PROMOTING THE SPEED OF SUPERSPORT BIKES, NOTING THAT "SPEED" WAS CITED IN 57% OF THE SUPERSPORT FATAL CRASHES AND 46% OF THE FATAL SPORT AND UNCLAD SPORT MOTORCYCLE ACCIDENTS.

SUPERSPORT BIKES ALSO HAVE THE HIGHEST OVERALL COLLISION COVERAGE LOSSES AMONG 2002 TO 2006 MODEL BIKES, A FIGURE ALMOST FOUR TIMES HIGHER THAN TOURING MOTORCYCLES AND SIX TIMES HIGHER THAN CRUISERS. THE BIKES ARE ALSO POPULAR TARGETS AMONG THIEVES, STOLEN AT A RATE SEVEN TIMES HIGHER THAN THE AVERAGE FOR ALL 2002 TO 2006 MOTORCYCLES.

"SHORT OF BANNING SUPERSPORT AND SPORT MOTORCYCLES FROM PUBLIC ROADWAYS, CAPPING THE SPEED OF THESE STREET-LEGAL RACING MACHINES AT THE FACTORY MIGHT BE ONE WAY TO REDUCE THEIR RISK," SUGGESTS THE IIHS REPORT ON THE STUDY.

IN THE LATE-80s THE IIHS CONVINCED MISSOURI SENATOR JOHN DANFORTH TO INTRODUCE A BILL IN CONGRESS CALLING FOR HORSEPOWER LIMITS ON ALL MOTORCYCLES SOLD IN THE U.S., BUT HE WITHDREW HIS CONTROVERSIAL "SUPER BIKE BAN" FOLLOWING INTENSE LOBBYING BY MOTORCYCLISTS' RIGHTS ACTIVISTS AND THE MOTORCYCLE INDUSTRY.

**BRITISH CHARITY DEMANDS DOWNSIZING OF MOTORCYCLES** A ROW HAS ERUPTED IN ENGLAND AFTER AN INFLUENTIAL ROAD SAFETY CHARITY, ROADPEACE, CALLED ON THE GOVERNMENT TO LIMIT THE WEIGHT, SPEED AND POWER OF HIGH-SPEED MOTORCYCLES IN AN EFFORT TO SLOW THE PACE OF RISING RIDER FATALITIES. MAKE BIKES SLOWER TO SAVE LIVES, CLAIMS THE CHARITY IN CORRESPONDENCE WITH THE TRANSPORT SELECT COMMITTEE DEMANDING THAT MINISTERS ISSUE NEW REGULATIONS "DOWNSIZING" MOTORCYCLES.

THE MOVE HAS SPARKED A FURIOUS REACTION FROM THE BRITISH MOTORCYCLE FOUNDATION, NOTES THE EVENING STANDARD NEWSPAPER, AND THE BMF HAS QUIT ROADPEACE CLAIMING IT HAS BEEN BETRAYED BY THE ORGANIZATION IT HAS BEEN AN ACTIVE MEMBER OF SINCE 2002.

THE FEDERATION ALSO QUESTIONED THE CHARITY'S FIGURES, POINTING OUT THAT THE MAJORITY OF MOTORCYCLE ACCIDENTS INVOLVED RIDERS OF BIKES WITH ENGINES UNDER 125CC. IT SUGGESTED THAT PEDESTRIANS AND CYCLISTS WERE RESPONSIBLE FOR MANY COLLISIONS WITH MOTORCYCLES. IN A STATEMENT, THE BMF SAID: "THE VAST MAJORITY OF MOTORCYCLE ACCIDENTS ARE CAUSED BY OTHER ROAD USERS, ROAD DEFECTS OR BY POOR ROAD DESIGN."

SHEILA RAINGER OF THE RAC FOUNDATION, A MOTOR VEHICLE SAFETY CHARITY, SAID: "ROADPEACE IS AUTHORITATIVE AND IS LISTENED TO BUT, UNFORTUNATELY, IN THIS CASE ITS DEMANDS ARE BASED ON EMOTION, NOT FACTS."

**SOUNDING OFF ON THE NOISE ISSUE** AS RECORD NUMBERS OF MOTORCYCLES HIT THE ROAD, STATES AND LOCALITIES FROM DENVER TO NEW YORK ARE CRACKING DOWN ON MOTORCYCLE NOISE. MOTORCYCLES HAVE SET NEW SALES RECORDS FOR 14 CONSECUTIVE YEARS, WITH 1.2 MILLION NEW BIKES SOLD LAST YEAR, BUT NOT EVERYBODY IS HAPPY WITH THE SOUND OF THAT. AS OF JULY 1, RIDERS IN NEW YORK CAN GET SLAPPED WITH \$440 IN FINES FOR HAVING LOUD EXHAUST PIPES. THOSE REVVING THEIR ENGINES TOO LOUDLY IN LANCASTER, PENNSYLVANIA CAN GET \$150 TICKETS. IN DAYTONA BEACH A CITY ORDINANCE PROHIBITS OPERATING "ANY NOISE-CREATING DEVICE FOR THE PURPOSE OF DRAWING ATTENTION TO THE SOURCE OF THE NOISE." DENVER NOW ALLOWS POLICE TO FINE THE OWNERS OF MOTORCYCLES WITH MUFFLERS THAT ARE NOT CERTIFIED BY THE ENVIRONMENTAL PROTECTION AGENCY (EPA), WHICH SETS FEDERAL NOISE-POLLUTION STANDARDS.

COLORADO AIM (AID TO INJURED MOTORCYCLISTS) ATTORNEY WADE ELDRIDGE SUCCESSFULLY CHALLENGED THE FIRST TWO TICKETS ISSUED UNDER DENVER'S NEW NOISE ORDINANCE, LARGELY BECAUSE THE POLICE DIDN'T USE SOUND METERS, AND ABATE OF NORTH DAKOTA IS PLANNING A COURT CHALLENGE AND HAS ENLISTED THE ASSISTANCE OF AIM ATTORNEY RALPH VINJE TO FIGHT TWO CITATIONS ISSUED UNDER A NEW BISMARCK MUNICIPAL NOISE ORDINANCE, WHERE OFFICERS ARMED WITH PORTABLE DECIBEL METERS HAVE BEEN OVERZEALOUSLY ENFORCING THE NEW LAW SINCE IT WENT INTO EFFECT AUGUST 1ST.

ABATE'S ATTORNEY, VINJE, TOLD THE BISMARCK TRIBUNE THAT IF THE POLICE ORDER AN ENGINE BE REVVED FOR TESTING PURPOSES THERE ISN'T MUCH CHOICE, BUT HE WOULDN'T SUBMIT TO THE TEST VOLUNTARILY. "THE ABILITY TO MAKE NOISE IS NOT THE SAME AS MAKING NOISE," SAID VINJE, WHO OWNS A HARLEY-DAVIDSON WITH NON-STOCK EXHAUST. "IF THEY STOP ME FOR LITTLE OR NO REASON AND HAVE YOU REV UP YOUR ENGINE, THAT'S LIKE ASKING YOU TO BREAK THE LAW."

"MY SPEEDOMETER INDICATES MY VEHICLE IS CAPABLE OF DOING 120 MPH, BUT THAT DOESN'T MEAN I WILL," ADDED MICHAEL JAY, EXECUTIVE DIRECTOR OF ABATE. VINJE AND JAY FEEL THAT LOUD PIPES DO PROVIDE EXTRA PROTECTION FOR MOTORCYCLISTS, ANNOUNCING THEIR PROXIMITY TO DRIVERS IN ENCLOSED VEHICLES.

THE NOISE LAW "LENDERS ITSELF TO ARBITRARY AND DISCRIMINATORY ENFORCEMENT," SAID AIM ATTORNEY ELDRIDGE, WHO IS ALSO LEGAL COUNSEL FOR THE CONFEDERATION OF CLUBS OF COLORADO, "THE POLICE CAN STOP YOU FOR WHATEVER REASON."

**MOTORCYCLE SALES SLOW** THE RUNAWAY FREIGHT TRAIN OF MOTORCYCLE SALES MAY FINALLY BE SLOWING DOWN. FOR MORE THAN A DECADE, MOTORCYCLES RECORDED RECORD SALES FIGURES, OFTEN SHOWING DOUBLE-DIGIT ANNUAL INCREASES, DEFYING NATIONWIDE ECONOMIC SLOWDOWNS AND STOCK MARKET DIPS. BUT FOR THE FIRST HALF OF 2007 THE MOTORCYCLE INDUSTRY COUNCIL REPORTS THAT U.S. MOTORCYCLE SALES ARE DOWN FOR THE FIRST TIME SINCE THE MID-90S, AND WERE OFF BY 7% COMPARED TO THE FIRST SIX MONTHS OF LAST YEAR.

THEORIES ABOUND, WITH SOME SUGGESTING THE RISE IN GAS PRICES AND BLEAK ECONOMIC PICTURE ARE MAKING CONSUMERS CAUTIOUS. OTHERS SAY SUB-PRIME CONCERNS IN THE HOUSING AND AUTO SECTORS ARE MAKING LOANS LESS AVAILABLE. OTHERS BLAME A SUMMER OF FREAKY WEATHER. OTHERS SAY THE SLIGHT DECLINE IN SALES NATIONWIDE IS A BLIP THAT WON'T LAST, AND POINT OUT THAT 2007 WILL STILL BE THE THIRD-LARGEST YEAR FOR MOTORCYCLE SALES.

DEALERS NOTED THAT WITH SUPPLY CATCHING UP TO DEMAND NATIONWIDE, CONSUMERS ARE GETTING BETTER DEALS, WITH FINANCING INCENTIVES, STABLE PRICING, AND GREAT VALUES WITH ADDED FEATURES SUCH AS ANTI-LOCK BRAKES, FUEL INJECTION AND OTHER TECHNICAL IMPROVEMENTS FOR VERY LITTLE ADDITIONAL COST TO CONSUMERS.

DEALERSHIPS HAVE REPORTED SEEING AN INCREASE IN SALES OF TOURING BIKES AND SPORT-TOURING MODELS, AS GRAYING RIDERS - AND THEIR WIVES IN THE PASSENGER SEAT - SEEK BIGGER MORE COMFORTABLE RIDES. ANOTHER TREND, AGAIN DRIVEN BY THE AGING BIKER POPULATION, IS THE MOVE TO TRIKES. NEW BIKE BUYERS ARE ALSO DEMANDING SUCH ADD-ONS AS SATELLITE NAVIGATIONAL SYSTEMS, EVEN THOUGH THEY ARE RELATIVELY EXPENSIVE.

MOTORCYCLE SALES NATIONALLY HAVE ALWAYS BEEN SOMEWHAT INDEPENDENT OF PRACTICAL ECONOMICS, WADE RICE OF RICE HONDA-SUZUKI-VICTORY TOLD THE RAPID CITY JOURNAL. "THEY SAY 3 PERCENT OF THE POPULATION RIDES MOTORCYCLES. THAT'S THE BAD NEWS," RICE SAID, BUT FROM THE DEALERS' PERSPECTIVE, "THE GOOD NEWS IS THAT 28 PERCENT WANT THEM."

**WEIRD NEWS:** 2 WHEELS + 160 MPH + SCHOOL ZONE = 3 YEARS OF LOCKUP ACCORDING TO NBC, A 20 YEAR-OLD MESA, ARIZONA MOTORCYCLIST WAS RECENTLY SENTENCED TO THREE YEARS IN PRISON FOR RIDING HIS 2006 HONDA CBR 600 THROUGH A SCHOOL ZONE AND CROSSWALK AT SPEEDS OVER 160 MPH. LAW ENFORCEMENT OFFICIALS FIRST SPOTTED THE EX-RACER TRAVELING AT ROUGHLY 140 MPH THROUGH MORNING RUSH HOUR TRAFFIC, AND A 30 MINUTE PURSUIT ENDED WITH A FOOT CHASE THAT RESULTED IN THE MAN'S ARREST. APPARENTLY, HIS HISTORY OF RECKLESS DRIVING AND RIDING UNDER A SUSPENDED LICENSE DIDN'T HELP HIS ARGUMENT IN COURT.

**CANADIAN COLORS CASE GOES TO COURT** IN WHAT IS BELIEVED TO BE A PROVINCIAL FIRST, A TRIAL DATE HAS BEEN SET FOR A HELLS ANGELS MEMBER WHO WAS CHARGED FOR WEARING HIS CLUB COLORS IN A BAR, IN VIOLATION OF SASKATCHEWAN'S NEW COLORS BAN.

RICHARD BANDET, 34, IS CHARGED WITH THE TICKET OFFENCE UNDER A PROVISION OF THE SAFER COMMUNITIES AND NEIGHBOURHOODS ACT (SCAN) THAT MAKES IT AGAINST THE LAW TO WEAR "GANG COLOURS" IN LICENSED ESTABLISHMENTS LIKE BARS. UNDER THE ACT, "COLOURS" REFERS TO "ANY SIGN, SYMBOL, LOGO OR OTHER REPRESENTATION IDENTIFYING, ASSOCIATED WITH OR PROMOTING A GANG OR A CRIMINAL ORGANIZATION."

ON JUNE 9, DURING THE SAME WEEKEND AS A POKER RUN INVOLVING THE CLUB, MOOSE JAW POLICE WERE CHECKING LOCAL BARS FOR SCAN INFRACTIONS WHEN THEY NOTICED A BIKER WEARING HIS COLORS.

UNDER SCAN, THOSE FOUND GUILTY OF A FIRST OFFENCE UNDER THE GANG COLORS SECTION OF THE LEGISLATION FACE A MAXIMUM \$10,000 FINE AND/OR ONE YEAR IN JAIL. SUBSEQUENT OFFENCES CARRY A MAXIMUM FINE OF \$25,000 AND/OR ONE YEAR IN JAIL.
