President's Message

BROTHERS AND SISTERS,

WE RIDE THROUGH RAIN STORMS THAT BLIND MOST MOTORISTS, STAND IN THE BROILING SUN, FREEZE OUR BUTTS OFF AND SHELL OUT OUR MONEY LIKE WE'RE WEALTHY PHILANTHROPISTS SUPPORTING CHARITIES, DONATE OUR BLOOD, SUPPORT OUR VETERANS AND THE AGEING, HELP CHILDREN THAT ARE STRICKEN BY DISEASE AND CRIPPLED, PATRONIZE BUSINESS' AND OTHER ESTABLISHMENTS DURING TOUGH TIMES TO KEEP THEM GOING AND GIVE OF OURSELVES IN SO MANY DIFFERENT WAYS THERE SHOULD BE A NATIONAL "BIKER APPRECIATION DAY" AND YET WE ASK FOR NOTHING IN RETURN OTHER THAN TO BE ALLOWED TO ENJOY OUR FREEDOM AND LIVE OUR LIFESTYLE IN PEACE.

BUT THAT CAN'T HAPPEN HERE, NOT IN AMERICA. IT'S NOT ENOUGH THAT MANY OF US HAVE FOUGHT ON FOREIGN SOIL TO PROTECT THOSE WHO WERE DEFENSELESS AND SUPPRESSED,

SOME OF US BARE THE SCARS TO PROVE IT, OTHERS HAVE SCARS THAT ARE NOT SO EVIDENT, BUT WE ALL HAVE A COMMON THREAD, WE ARE PROUD TO HAVE COME TOGETHER AS AMERICANS, AS BROTHERS AND SISTERS. WE CHOSE TO SEEK OUT OTHERS THAT HAVE SHARED OUR EXPERIENCES AND A BOND FORMED BETWEEN US. WE FOUND ANOTHER COMMONALITY, WE RIDE MOTORCYCLES, SOME OF US CHOSE TO FORM ORGANIZATIONS TO SUPPORT OUR BROTHERHOOD IN BECOMING CLUBS. IT BECOMES AN ELITE ORGANIZATION FOR A REASON, IT MEANS THAT WE ARE ACCEPTED AS SOMEONE THAT WANTS TO BE A PART OF THAT BROTHERHOOD AND IS WILLING TO PROVE HIS WORTH, TO BE ACCEPTED BY RIGHT OF PASSAGE. WHEN SOMEONE RECEIVES THEIR PATCH THEY BECOME A MEMBER OF AN EXTENDED FAMILY. SOME OF US CHOOSE TO RIDE AS INDEPENDENTS OR BELONG TO OTHER RIDING ASSOCIATIONS. AS A MEMBER OF ABATE I WEAR MY PATCH WITH PRIDE AND HONOR, IT STATES THAT I HAVE MADE A CHOICE, I CHOOSE FREEDOM AND I'M WILLING TO STAND SHOULDER TO SHOULDER WITH MY BROTHERS AND SISTERS TO FIGHT FOR THE RIGHTS OF ALL MOTORCYCLISTS. IT'S MY COMMITMENT AND HOPEFULLY A SMALL CONTRIBUTION TO THIS EXTENDED FAMILY AS A MEMBER OF THE MOTORCYCLE COMMUNITY.

FOR YEARS WE HAVE DONE EVERYTHING WE COULD TO SERVE AS EXAMPLES OF A SOCIETY WITHIN A SOCIETY THAT IS WILLING TO CO EXIST AND AGAIN, WITHOUT ANY EXPLANATION OR PROVOCATION WE ARE BEING TURNED AWAY. I BELIEVE IT'S NOT BECAUSE OF WHO WE ARE, IT'S BECAUSE OF WHAT WE REPRESENT, SOMETHING THAT SOCIETY CANNOT ACCEPT. WE ARE AGAIN BEING DENIED OUR RIGHTS AS CITIZENS, LET ME RE PHRASE THAT, WE ARE BEING DISCRIMINATED AGAINST BY CITIZENS BECAUSE WE WEAR A PATCH ON OUR BACK. IT'S HAPPENING RIGHT HERE IN OUR OWN BACKYARD. WHEN ANYONE DENIES ONE OF US ENTRY OR REFUSES US SERVICE THEY INSULT US ALL. WHAT WOULD ANY OTHER GROUP OF INDIVIDUALS DO? GOD FORBID IT BE DEEMED AS AN ACT WITH RACIAL OVERTONES, YOU'D HAVE THE A.C.L.U. AND LOCAL CIVIC GROUPS FALLING OVER EACH OTHER TRYING TO GET THERE FIRST. THE MOST RECENT INSULT TO US COMES FROM THE OLD KEY LIME HOUSE, DECLARING INDIVIDUALS WEARING COLORS ARE NO LONGER WELCOME. THEY TELL YOU YOU'LL HAVE TO LEAVE THEM OUTSIDE. WHAT? WHAT DO THEY CONSIDER COLORS?

YOUR COLORS OR PATCH ARE ALWAYS WELCOME IN OUR HOUSE

WE SUPPORT MOTORCYCLIST'S RIGHTS, SAFETY AND AWARENESS OF ALL MOTORCYCLISTS AND WELCOME THE SUPPORT YOUR CLUB OR RIDING ASSOCIATION AS WELL AS ALL INDEPENDENTS, REGARDLESS OF WHAT KIND OF MOTORCYCLE YOU RIDE.

WE ARE NOT ANTI-HELMET, WE ARE ANTI-HELMET LAW

ONE OF THE MOST POPULAR MISCONCEPTIONS ABOUT ABATE IS THAT WE ARE ANTI-HELMET. NOTHING COULD BE FURTHER FROM THE TRUTH. WE ARE "ANTI-HELMET LAW" IF YOU CHOSE TO RIDE WITH OR WITHOUT A HELMET IT'S YOUR CHOICE, IT IS YOUR RIGHT TO DECIDE WHETHER WEARING A HELMET IS RIGHT FOR YOU. ABATE IS AN ORGANIZATION FIGHTING TO PROTECT YOUR RIGHTS.

WE ARE CURRENTLY PREPARING FOR THE OPENING OF THE NEW LEGISLATIVE SESSIONS. OUR LEGISLATIVE AGENDA INCLUDES "STIFFER PENALTIES" FOR RIGHT OF WAY VIOLATORS (ROWV), STILL THE NUMBER 1 KILLER OF MOTORCYCLISTS. A BAN ON CELL PHONE USE WHILE OPERATING A MOTOR VEHICLE OF ANY KIND AND MANDATORY DRIVERS EDUCATION COURSES AND CLASSES IN THE FLORIDA SCHOOL SYSTEM. WE NEED YOUR SUPPORT TO MAKE OUR VOICE HEARD AS MOTORCYCLISTS.





September Legislative & Delegate Report

THE BILLS ARE SLOOOOOWLY STARTING TO BE FILED FOR THE 2010 FLORIDA LEGISLATIVE SESSION. ALL OF THE SENATE BILLS FILED SO FAR (AS OF 9-3-09) ARE RELIEF BILLS THAT ARE ASKING FOR MONETARY PAYMENTS TO PEOPLE FOR A VARIETY OF REASONS. IN THE HOUSE, I HAVE FOUND FIVE THAT I AM PUTTING ON MY WATCH LIST. NONE OF THEM ARE DIRECTED AT MOTORCYCLIST, BUT I JUST FIND THEM INTERESTING AND I AM CURIOUS AS TO HOW FAR THEY WILL GO.

HM 19 LIMITING THE SCOPE AND EXERCISE OF FEDERAL POWER. (URGES CONGRESS TO HONOR PROVISIONS OF U. S. CONSTITUTION & U. S. SUPREME COURT CASE LAW WHICH LIMIT SCOPE & EXERCISE OF FEDERAL POWER.)

HB 21 REGULATION OF FIREARMS (CREATES FLORIDA FIREARMS FREEDOM ACT; PROVIDES LEGISLATIVE FINDINGS & DEFINITIONS; PROVIDES THAT SPECIFIED FIREARMS, FIREARM ACCESSORIES, & AMMUNITION FOR PERSONAL USE MANUFACTURED IN STATE ARE NOT SUBJECT TO FEDERAL LAW OR REGULATION; PROVIDES THAT IMPORTATION INTO STATE OF SPECIFIED PARTS & INCORPORATION OF SUCH PARTS INTO FIREARM, FIREARM ACCESSORY, OR AMMUNITION MANUFACTURED IN STATE DOES NOT SUBJECT FIREARM, FIREARM ACCESSORY, OR AMMUNITION TO FEDERAL REGULATION; PROVIDES THAT CERTAIN BASIC MATERIALS ARE NOT SUBJECT TO FEDERAL REGULATION OF FIREARMS, FIREARM ACCESSORIES, OR AMMUNITION UNDER INTERSTATE COMMERCE; PROVIDES THAT SPECIFIED FIREARM ACCESSORIES IMPORTED INTO STATE FROM ANOTHER STATE DO NOT SUBJECT FIREARM TO FEDERAL REGULATION UNDER INTERSTATE COMMERCE; PROVIDES LEGISLATIVE FINDINGS WITH RESPECT THERETO; PROVIDES EXCEPTIONS; PROVIDES APPLICABILITY; REQUIRES THAT FIREARMS MANUFACTURED & SOLD IN STATE MUST BEAR INDICIA OF MANUFACTURE BY SPECIFIED DATE.)

HJR 37 HEALTHCARE SERVICES (PROPOSES CREATION OF S. 28, ART. X OF STATE CONSTITUTION TO PROHIBIT LAWS OR RULES FROM COMPELLING ANY PERSON, EMPLOYER, OR HEALTH CARE PROVIDER TO PARTICIPATE IN ANY HEALTH CARE SYSTEM; PERMIT PERSON OR EMPLOYER TO PURCHASE LAWFUL HEALTH CARE SERVICES DIRECTLY FROM HEALTH CARE PROVIDER; PERMIT HEALTH CARE PROVIDER TO ACCEPT DIRECT PAYMENT FROM PERSON OR EMPLOYER FOR LAWFUL HEALTH CARE SERVICES; EXEMPT PERSONS, EMPLOYERS, & HEALTH CARE PROVIDERS FROM PENALTIES & FINES FOR PAYING OR ACCEPTING DIRECT PAYMENT FOR LAWFUL HEALTH CARE SERVICES; PERMIT PURCHASE OR SALE OF HEALTH INSURANCE IN PRIVATE HEALTH CARE SYSTEMS; & SPECIFIES WHAT AMENDMENT DOES NOT AFFECT OR PROHIBIT.)

HB 41 USE OF AN ELECTRONIC WIRELESS COMM. DEVICE WHILE DRIVING. (PROHIBITS OPERATION OF MOVING MOTOR VEHICLE WHILE READING, MANUALLY WRITING OR TYPING, OR SENDING MESSAGE ON ELECTRONIC WIRELESS COMMUNICATIONS DEVICE; PROVIDES EXCEPTIONS & PENALTIES.)

HB 71 DEPT OF HIGHWAY SAFETY AND MOTOR VEHICLES. (DECREASES FEES & CHARGES FOR REINSTATEMENT OF DRIVER LICENSE, CERTIFICATES OF TITLE, REGISTRATION OF MOTOR VEHICLE, LICENSE PLATES, VALIDATION DECALS, & MOBILE HOME STICKERS, INITIAL REGISTRATION APPLICATION FOR CERTAIN VEHICLES, DRIVER'S LICENSE EXAMINATIONS, SERVICES & DOCUMENTS, DRIVER'S LICENSES, RETURN OF LICENSE SUSPENDED, & DUI PROGRAM ENROLLMENT; REMOVES FEE & SERVICE CHARGE FOR PUBLICATION & DELIVERY OF NOTICE GIVEN BY CERTAIN LICENSED DEALERS, LISTS OF MOTOR VEHICLE & VESSEL RECORDS, & HEARING ON OR REVIEW OF CERTAIN ACTIONS; DECREASES ANNUAL LICENSE TAXES FOR OPERATION OF CERTAIN VEHICLES.)





MULTI-FACETED MOTORCYCLE BILL ENACTED IN TEXAS SENATE
BILL 1967, AUTHORED BY TEXAS STATE SENATOR JOHN CARONA (R-

DALLAS) AND SPONSORED BY REPRESENTATIVE NORMA "DA'LADY" CHAVEZ (D-EL PASO), INTRODUCES MANY MOTORCYCLE-RELATED CHANGES IN THE LONE STAR STATE. INCLUDED IN THE BILL ARE 1) FUNDING BY TEXAS DEPARTMENT OF TRANSPORTATION FOR A PUBLIC AWARENESS CAMPAIGN TO PROMOTE MOTORCYCLIST SAFETY AND THE CONCEPT OF SHARING THE ROAD WITH MOTORCYCLISTS; 2) CHANGES TO THE DEFINITION OF A MOTORCYCLE TO INCLUDE CERTAIN ENCLOSED THREE-WHEELED PASSENGER VEHICLES; 3) CHANGES TO THE LICENSING REQUIREMENTS FOR ENCLOSED THREE-WHEELED PASSENGER VEHICLES; 4) A REQUIREMENT FOR ALL APPLICANTS FOR A MOTORCYCLE LICENSE OR ENDORSEMENT ON A REGULAR OR COMMERCIAL DRIVER'S LICENSE TO PROVIDE PROOF OF SUCCESSFUL COMPLETION OF A BASIC MOTORCYCLE OPERATOR TRAINING COURSE; 5) PENALTIES FOR FAILURE TO YIELD THE RIGHT-OF-WAY VIOLATIONS RESULTING IN BODILY INJURY RANGE FROM \$500 TO \$2,000 WHILE THOSE RESULTING IN SERIOUS BODILY INJURY RANGE FROM \$1,000 TO \$4,000; 6) A PROHIBITION AGAINST STOPPING OR DETAINING A MOTORCYCLE OPERATOR OR PASSENGER SOLELY TO DETERMINE WHETHER THE PERSON HAS SUCCESSFULLY COMPLETED A MOTORCYCLE OPERATOR TRAINING AND SAFETY COURSE OR IS COVERED BY A HEALTH INSURANCE PLAN; 7) A REQUIREMENT FOR THE DEPARTMENT OF TRANSPORTATION TO DEVELOP A STANDARD OF PROOF OF HEALTH INSURANCE COVERAGE FOR ADULT MOTORCYCLE OPERATORS AND PASSENGERS; AND 8) A REQUIREMENT THAT ALL DRIVER EDUCATION COURSES OR DRIVING SAFETY COURSES INCLUDE INFORMATION ON MOTORCYCLE AWARENESS, DANGERS OF FAILURE TO YIELD THE RIGHT-OF-WAY TO MOTORCYCLISTS, AND THE NEED TO SHARE THE ROAD WITH MOTORCYCLISTS.

GOVERNOR RICK PERRY SIGNED THE BILL INTO LAW ON JUNE 19; IT BECOMES EFFECTIVE SEPTEMBER 1, 2009.

WE MADE HISTORY, WARRIORS," EXCLAIMED SPUTNIK, STATE CHAIRMAN OF THE TEXAS MOTORCYCLE RIGHTS ASSOCIATION (TMRA-II) AND CHAIRMAN OF THE NATIONAL COALITION OF MOTORCYCLISTS LEGISLATIVE TASK FORCE (NCOM-LTF). "WE OWE DA'LADY AND HER ENTIRE STAFF A HUGE DEBT OF GRATITUDE FOR ALL THE WORK THEY DID FOR RIDERS THIS SESSION."

MISSOURI RIDERS SEEING RED FOR MOST DRIVERS, RED MEANS STOP. BUT IF YOU'RE RIDING A MOTORCYCLE OR A BICYCLE IN MISSOURI, IT WILL SOON MEAN STOP, BUT ONLY SORT OF. A NEW MISSOURI LAW THAT TAKES EFFECT AUG. 28 ALLOWS MOTORCYCLE AND BIKE RIDERS TO RUN RED LIGHTS, BUT ONLY IF THEY STOP FIRST AND THE SIGNAL REMAINS RED FOR AN "UNREASONABLE TIME."

MISSOURI WILL JOIN A GROWING NUMBER OF STATES THAT HAVE ENACTED SIMILAR LAWS, WHICH ARE INTENDED TO ADDRESS OCCASIONS WHEN MOTORCYCLES OR BIKES AREN'T DETECTED BY TRAFFIC SIGNAL SENSORS IN THE ROAD. MANY TRAFFIC SIGNALS ARE TRIGGERED BY A MAGNETIC REACTION COUPLED WITH WIRES EMBEDDED IN THE PAVEMENT. THE WIRES ARE SIZED IN SUCH A WAY THAT THEY ARE MORE LIKELY TO BE TRIPPED BY A CAR OR TRUCK, BUT SOME MOTORCYCLES AND BIKES

CONTINUED

TEND NOT TO TRIP THE SIGNAL BECAUSE THEY HAVE LESS MASS AND ARE MADE WITH PARTS THAT AREN'T ATTRACTED TO A MAGNET.

IN CITIES WITH INTERSECTIONS PATROLLED BY RED-LIGHT CAMERAS, WHEN A PICTURE IS TAKEN OF A RED-LIGHT RUNNER, POLICE SHOULD BE ABLE TO APPLY THE LAW BY LOOKING AT VIDEO OF THE POSSIBLE VIOLATION, AND IF A RIDER DOES GET A TICKET THE NEW LAW WILL PROVIDE A DEFENSE.

MISSOURI IS THE EIGHTH STATE TO PASS THIS KIND OF LAW SINCE 2002, AND THREE OTHER STATES CONSIDERED SIMILAR LEGISLATION THIS YEAR.

NY STATE POLICE SUED OVER MOTORCYCLE-ONLY ROADBLOCKS UPSTATE NEW YORK HAS EARNED A REPUTATION AS THE SPEEDING TICKET CAPITAL OF THE COUNTRY, BUT EVEN WITH OVEREAGER STATE TROOPERS PATROLLING THE HIGHWAYS, MOTORCYCLISTS FEEL SINGLED OUT BY LAW ENFORCEMENT. THAT'S WHY ONE RIDER/ATTORNEY IS TAKING THE STATE POLICE, ALONG WITH COUNTY AND STATE OFFICIALS TO COURT.

ACCORDING TO LEGAL DOCUMENTS FILED BY MITCH PRONER, AID TO INJURED MOTORCYCLISTS (AIM) ATTORNEY FOR NEW YORK, THE STATE'S INSTITUTION OF ROADBLOCKS EXCLUSIVELY FOR MOTORCYCLISTS IS UNCONSTITUTIONAL: THE MOTORCYCLIST AND PERSONAL INJURY LAWYER CLAIMS THAT WITHOUT JUSTIFIABLE CAUSE, THE CHECKPOINTS INFRINGE ON RIDERS' FIRST AMENDMENT RIGHTS TO FREEDOM OF ASSEMBLY AND ASSOCIATION AND THEIR FOURTH AMENDMENT RIGHT TO FREEDOM FROM UNREASONABLE SEARCH AND SEIZURE.

FOR NEARLY TWO YEARS NOW, THE NEW YORK STATE POLICE (NYSPP) HAVE BEEN CONDUCTING HIGHWAY ROADBLOCKS DIVERTING ONLY MOTORCYCLISTS FROM THE STATE'S ROADWAYS TO PERFORM "SAFETY CHECKS". ACCORDING TO ABATE OF NEW YORK, "SINCE MOTORCYCLES OPERATED IN NEW YORK ARE ALREADY REQUIRED TO PASS ANNUAL SAFETY INSPECTIONS, THE CURRENT NYSP INITIATIVE CONTINUES TO SERVE ONLY TO HARASS, INTIMIDATE AND INCONVENIENCE MOTORCYCLISTS TRAVELING UPON THE STATE'S ROADWAYS. FURTHER, MOTORCYCLE-ONLY ROADBLOCKS OF THIS NATURE ARE A DISCRIMINATORY AND UNCONSTITUTIONAL INFRINGEMENT UPON AN INDIVIDUAL'S RIGHT TO TRAVEL WITHOUT INTERFERENCE, AND AN ABUSE OF DISCRETIONARY POWER AS ACKNOWLEDGED BY THE NEW YORK STATE COURT OF APPEALS."

PRONER TOLD AUTOBLOG.COM THAT HE IS FILING THE FEDERAL CLASS ACTION SUIT AT THE FEDERAL COURT FOR THE NORTHERN DISTRICT OF NEW YORK ON BEHALF OF HIS FELLOW RIDERS. ABATE OF NEW YORK HAS PLEDGED SUPPORT OF THE CLASS-ACTION INITIATIVE BROUGHT ON BEHALF OF THE NATIONAL COALITION OF MOTORCYCLISTS (NCOM).

CITIES MUFFLE MOTORCYCLE NOISE MANY STATE LEGISLATURES AND CITY COUNCILS ARE MAKING LOTS OF NOISE ABOUT MOTORCYCLES, WITH NEW ORDINANCES POPPING UP ACROSS THE COUNTRY TO SILENCE LOUD EXHAUSTS. "LOUD PIPES SAVE LIVES" HAS BEEN A BIKER MANTRA FOR YEARS, BUT POLITICIANS SPURRED BY CITIZEN COMPLAINTS HAVE DISCOVERED NEW WAYS TO MUFFLE UNWANTED EXHAUST TONES.

THE ALBUQUERQUE CITY COUNCIL VOTED 6-3 EARLIER THIS MONTH TO APPROVE AN ORDINANCE MAKING REVVING OF MOTORCYCLE ENGINES DOWNTOWN A VEHICLE NUISANCE. AMENDING SECTION 7-10-3 ROA 1994, THE VEHICLE NUISANCE ORDINANCE NOW READS: "IT SHALL BE UNLAWFUL

CONTINUED

FOR ANY PERSON TO ENGAGE IN EXHIBITION DRIVING IN THE DOWNTOWN QUIET ZONE BY OPERATING A VEHICLE IN A MANNER THAT WILLFULLY CREATES EXCESSIVE ENGINE NOISE BECAUSE OF REVVING THE ENGINE TO MAGNIFY THE ENGINE NOISE."

BIKERS BLASTING THROUGH EAST GREENWICH, RHODE ISLAND MAY WANT TO STEER CLEAR OF TOWN IF THEIR EXHAUST SYSTEMS AREN'T THE PROPER MATCH FOR THEIR BIKES. THE TOWN COUNCIL UNANIMOUSLY PASSED AN EMERGENCY ORDINANCE IN LATE JULY ALLOWING THE POLICE TO PULL OVER AND LEVY FINES ON BIKERS IF THE NOISE-RATING DATA STAMPED INTO THE CHROME OF THEIR EXHAUST DOESN'T MATCH THE LABEL ON THE BIKE FRAME. MODIFIED EXHAUST SYSTEMS ARE OUTLAWED.

THE ORDINANCE, NOW IN EFFECT, PROVIDES FOR FINES \$500 FOR THE FIRST OFFENSE, AND JUMPS TO \$700 THE SECOND TIME AND \$1,000 FOR THE THIRD AND EACH SUBSEQUENT VIOLATION. BUDDY CARDOSO, PRESIDENT OF THE RHODE ISLAND MOTORCYCLE ASSOCIATION, WHO SAID HIS GROUP SUPPORTS COURTEOUS RIDING, INQUIRED THAT IF THE LABELS HAVE TO MATCH, "WHAT DO YOU DO, THROW AWAY THE MOTORCYCLE IF THE EXHAUST WEARS OUT?" OWNERS OF OTHER VEHICLES ARE ALLOWED TO USE AFTER-MARKET EXHAUST SYSTEMS, AND IT IS UNFAIR TO SINGLE OUT BIKERS, HE SAID.

IN WEST VIRGINIA, THE CHARLESTON CITY COUNCIL LET IT BE KNOWN LOUD AND CLEAR THAT NUISANCE NOISE WILL NOT BE TOLERATED, AND UNANIMOUSLY PASSED AN ORDINANCE ON AUGUST 17 TO CRACK DOWN ON LOUD MUSIC, BARKING DOGS AND REVVING OF CAR AND MOTORCYCLE ENGINES IN RESIDENTIAL AREAS, WITH FINES UP TO \$250.

IN AN ATTEMPT TO SILENCE COMMUNITY CONCERNS REGARDING EXCESSIVE MOTORCYCLE EXHAUST SOUND, THE BOSTON CITY COUNCIL FAST-TRACKED ENACTMENT OF DOCKET O658 ON JUNE 3, 2009. THE NEW ORDINANCE MANDATES THAT ALL ON-HIGHWAY MOTORCYCLES BUILT AFTER DECEMBER 31, 1982 MUST HAVE EITHER OEM (ORIGINAL EQUIPMENT MANUFACTURER) OR AFTERMARKET EXHAUST SYSTEMS THAT COMPLY WITH THE US EPA LABELING PROVISION IN THE CODE OF FEDERAL REGULATIONS. VIOLATIONS WILL RESULT IN A \$300 FINE.

EARLIER THIS YEAR IN CALIFORNIA A BILL WAS HELD OVER THAT WOULD HAVE REQUIRED PERIODIC EMISSIONS TESTING FOR 2000-AND-NEWER ON-ROAD MOTORCYCLES IN AN EFFORT TO MAKE AFTERMARKET EXHAUST SYSTEMS ILLEGAL IF THEY DO NOT COMPLY WITH EPA LABELING.

MEANWHILE, THE MOTORCYCLE INDUSTRY COUNCIL HAS TEAMED WITH THE SOCIETY OF AUTOMOTIVE ENGINEERS INTERNATIONAL (SAE) TO PRODUCE A STATIONARY ROADSIDE SOUND TEST STANDARD THAT CAN BE USED TO DETERMINE WHETHER A STREETBIKE EXHAUST SYSTEM EMITS EXCESSIVE SOUND. "THE NEW SAE STANDARD PROVIDES A MUCH-NEEDED ALTERNATIVE TO OUTRIGHT BANS, RESTRICTIONS AND SOUND TEST STANDARDS THAT VARY STATE TO STATE AND CITY TO CITY, FRUSTRATING RIDERS, EXHAUST SYSTEM MANUFACTURERS, AND MUNICIPAL GOVERNMENTS ALIKE," SAID MIC PRESIDENT TIM BUCHE.
