# PRESIDENT'S MESSAGE

## BROTHERS AND SISTERS

AFTER A RELATIVELY QUITE YEAR IN REGARD TO NEW LEGISLATION AIMED SPECIFICALLY AT MOTORCYCLISTS, THE FED'S DECIDED TO GIVE US A PREVIEW OF WHAT WE CAN LOOK FORWARD TO FOR 2011. YEP, THEY'RE AT IT AGAIN; THE NTSB (NATIONAL TRANSPORTATION SAFETY BOARD) IS CALLING FOR ALL STATES TO ADOPT A MANDATORY HELMET LAW. WE HAD HEARD THERE WAS A POSSIBILITY THERE WOULD BE NEW LEGISLATION PROPOSED TO *IMPOSE* A NATIONAL HELMET LAW BUT UP UNTIL JUST THE LAST COUPLE MONTHS IT WAS MORE LIKE A NASTY RUMOR. THE FACT IS THEY NEVER STOPPED TRYING THEY JUST KEEP PLAYING WITH STATISTICS UNTIL THEY COME UP WITH A NEW PITCH TO SWAY PUBLIC OPINION. AS WE ALL KNOW THE MEDIA HAS BEEN RELENTLESS IN REPORTING EVERY ACCIDENT INVOLVING A MOTORCYCLE WITH WHETHER THEY WERE OR WERE NOT WEARING A HELMET REGARDLESS OF THE FACTS SURROUNDING THE ACCIDENT AND CAUSE.

WHEN YOU CONSIDER THE STATISTICS CLEARLY SHOW MANY MORE PEOPLE SUFFER HEAD TRAUMA FROM MOTOR VEHICLE CRASHES I CAN ONLY OFFER MY OWN THEORY ON THE REASON WHY THE HELMET ISSUE REMAINS. IT'S EASIER TO FOCUS ON THE OBVIOUS THAN FIX THE REAL PROBLEM. WE AS MOTORCYCLISTS UNDERSTAND THE RISKS INVOLVED WHEN RIDING MOTORCYCLES AND TO NON- RIDERS IT APPEARS TO BE A DANGEROUS WAY TO TRAVEL AND IT CAN BE GIVEN THE CIRCUMSTANCES, BUT IT'S



SOMETHING WE DEAL WITH EVERY TIME WE KICK A LEG OVER OUR BIKES. WE ACCEPT THE RISKS AND THE MAJORITY OF RIDER'S TAKE THE NECESSARY PRECAUTIONS AND PAY MORE ATTENTION TO "THE OTHER GUY" THAN MOST MOTORISTS.

SO, WHY MOTORCYCLISTS? WE'RE THE ONE'S THAT HAVE TO BE CERTIFIED TO RIDE LEGALLY. WE'RE THE ONE'S WHO ARE USUALLY THE VICTIMS IN ACCIDENTS WITH OTHER VEHICLES, WHO FOR THE MOST PART CAUSE THE ACCIDENTS ACCORDING TO THE STATISTICS AND WE'RE THE ONE'S WHO SUFFER THE CONSEQUENCES IN THE MAJORITY OF THESE ACCIDENTS. SOMEHOW I JUST CAN'T BELIEVE, N.S.T.B. IS REALLY ALL THAT CONCERNED ABOUT US AS MOTORCYCLISTS, I MEAN IT'S A NICE THOUGHT, BUT IT SEEMS TO ME THAT IF THAT WERE THE CASE THEY WOULD BE MORE INVOLVED IN PREVENTION AND GOING TO THE SOURCE BY CALLING FOR A NATIONAL MANDATORY BAN ON TEXTING WHILE DRIVING, CELL PHONE USE OR AT LEAST RESTRICTING THE USE TO HANDS FREE, BOTH OF WHICH HAVE CONTRIBUTED TO THE INCREASE IN ACCIDENTS FOR ALL MOTORISTS. I WOULD

## PRESIDENT'S MESSAGE – CONT'D

THINK THAT ELIMINATING OR REDUCING RISK FACTOR OF DISTRACTED DRIVERS WOULD DEFINITELY HAVE AN IMPACT ON THE STATISTICS OF ACCIDENTS CAUSING HEAD TRAUMA, INJURY AND DEATH OF MOTORCYCLISTS AS WELL AS OTHER MOTORISTS.

IF HELMETS COULD PREVENT ACCIDENTS I WOULD PROBABLY UNDERSTAND WHY THEY'RE STILL PUSHING FOR THIS MEASURE BUT THEY DON'T, SO WHAT'S THEIR MOTIVE? IF IT'S PURELY A MATTER OF REDUCING THE COST OF MEDICAL CARE IN AMERICA, THEN PERHAPS THEY SHOULD GET WITH OTHER GOVERNMENT AGENCIES AND DO SOMETHING ABOUT GIVING FREE MEDICAL CARE TO ILLEGAL ALIENS. I'M NOT SAYING THEY SHOULDN'T BE CARED FOR IF IT'S AN EMERGENCY BUT I THINK THEY AND/OR THEIR MEDICAL RECORDS SHOULD BE TURNED OVER TO I.N.S. UPON BEING DISCHARGED. NO MORE FREE MEDICAL FOR ILLEGAL ALIENS, WHAT A CONCEPT, DO YOU THINK THAT WOULD BRING THOSE MEDICAL COSTS DOWN?

COULD IT BE THE INSURANCE COMPANIES PRESSURING THE N.S.T.B.? THAT WOULD PROBABLY MAKE MORE SENSE CONSIDERING THEY HAD TRIED AND FAILED TO RAISE THE MINIMUM ON PERSONAL INJURY RATES FOR MOTORCYCLISTS FROM \$10,000 TO \$50,000 HERE IN FLORIDA. AFTER ALL, THEIR MARKETING WIZARDS TOLD THEM HOW THEIR PROJECTED PROFIT MARGIN WOULD BE SIGNIFICANTLY HIGHER IF THEY COULD GET STATES WHERE THE HELMET LAWS WERE REPEALED TO FORCE LEGISLATION UPON US MAKING IT MANDATORY. OF COURSE WHEN THAT DIDN'T WORK, THEY WENT WHINING TO N.S.T.B. AND WE ALL KNOW THE INSURANCE INDUSTRY SWINGS A BIG STICK IN D.C. AND EVERY STATE IN AMERICA. I CERTAINLY THINK THEY HAVE THEIR HAND IN IT, PROBABLY MORE LIKE UP TO THEIR ELBOWS IN IT BUT I'M NOT SURE HOW THEY WOULD CAPITALIZE ON IT AT LEAST ENOUGH TO REALLY INCREASE THEIR PROFIT MARGINS. THEY'RE OBVIOUSLY NOT SELLING HELMETS, SO WHAT WOULD BE THEIR MOTIVATION TO SUPPORT THIS LEGISLATION.

AS LONG AS THE MEDIA CONTINUES TO REPORT EVERY ACCIDENT INVOLVING A MOTORCYCLE AS IF IT WAS THE MOTORCYCLISTS FAULT FOR NOT WEARING A HELMET AND REPORTING IT AS IF THE ACCIDENT COULD HAVE BEEN AVOIDED IF THE RIDER WAS WEARING A HELMET THE NON RIDING PUBLIC WILL KEEP BELIEVING THEM. LETS FACE IT, THE NON RIDING PUBLIC IS NEVER GOING TO HEAR FROM US IN THE SAME WAY THEY HEAR AND SEE THESE STORIES FROM THE MEDIA AND I SERIOUSLY DOUBT THAT THEY SPEND ANY TIME THINKING ABOUT IT ANYWAY, THEY'LL JUST GO ALONG WITH WHATEVER THEY ARE TOLD. UNTIL WE CAN FIND OUT WHO ACTUALLY PULLS THE STRINGS FOR THE MEDIA' BIASED REPORTING ON THIS ISSUE PUBLIC OPINION WILL NEVER CHANGE.

## PRESIDENT'S MESSAGE – CONT'D

THIS IS ANOTHER ASPECT OF OUR EDUCATIONAL PROGRAM, WE NEED TO BE ABLE TO MEET WITH PEOPLE IN THEIR COMMUNITIES AND WITH COMMUNITY LEADERS IN ORDER TO SET THE RECORD STRAIGHT. IT'S NOT AN EASY TASK BUT IT DEFINITELY NEEDS TO BE DONE. I HOPE TO BEGIN A CAMPAIGN FOCUSING ON CELL PHONE USE AND TEXTING WHILE DRIVING CALLED "No, YOU CAN'T, Nobody CAN" AFTER THE NEW YEAR AND I WOULD LIKE TO BE ABLE TO WORK WITH THE PRO'S AND CON'S OF HELMET USE AND WHY IT SHOULD BE LEFT UP TO THE INDIVIDUAL RIDER AS TO WHETHER THEY WEAR OR DON'T WEAR A HELMET AND WHY NON RIDERS AND GOVERNMENT SHOULD NOT INTERFERE IN OUR PERSONAL CHOICES.

IN MY OPINION IT'S JUST ANOTHER WAY FOR GOVERNMENT TO INTRUDE ON OUR PERSONAL LIVES AND TRY TO MAKE US THINK THEY KNOW BETTER THAN WE DO WHAT'S BEST FOR US. AS LONG AS ABATE AND OTHER MRO's EXIST THEY FEEL THREATENED, THEY DON'T HAVE TOTAL CONTROL AND THAT REALLY BOthers THEM. WE CANNOT NOT ALLOW THEM TO SUCCEED IN THEIR EFFORTS TO CONTROL US, PUTTING A MANDATORY NATIONAL HELMET LAW INTO EFFECT ISN'T ABOUT SAFETY, IT'S ABOUT GOVERNMENT TAKING OUR RIGHT TO GOVERN OURSELVES AWAY.

WE SAW THE EFFECT THE TEA PARTY MOVEMENT EFFECTED THE MID TERM ELECTIONS AND HOW TAKING A STAND CAN TURN THINGS AROUND, I BELIEVE IT'S TIME FOR US, AS MOTORCYCLIST TO TAKE A STAND AND PUT AN END TO THIS THROUGH EDUCATION. IF PEOPLE KNEW THE FACTS ABOUT HELMETS AND WHY IT SHOULD BE LEFT UP TO THE INDIVIDUAL RIDER AND THEIR PASSENGER AS TO WHETHER THEY WEAR ONE OR NOT THEN MAYBE THEY'LL UNDERSTAND WHY WE ARE NOT ANTI HELMET, WE ARE ANTI HELMET LAW.

IN CLOSING, I WANT TO WISH EVERYONE A VERY MERRY CHRISTMAS AND A HAPPY AND PROSPEROUS NEW YEAR. GOD BLESS US EVERY ONE.

ONE OF THE MOST POPULAR MISCONCEPTIONS ABOUT ABATE IS THAT WE ARE ANTI-HELMET. NOTHING COULD BE FURTHER FROM THE TRUTH. WE ARE "ANTI-HELMET LAW" IF YOU CHOSE TO RIDE WITH OR WITHOUT A HELMET IT'S YOUR CHOICE, IT IS YOUR RIGHT TO DECIDE WHETHER WEARING A HELMET IS RIGHT FOR YOU. ABATE IS AN ORGANIZATION FIGHTING TO PROTECT YOUR RIGHTS.

WE ARE CURRENTLY PREPARING FOR THE OPENING OF THE NEW LEGISLATIVE SESSIONS. 

THE FACT IS, IT'S DANGEROUS TO BE ON A MOTORCYCLE FOR MANY REASONS BUT I THINK THE STATISTICS WILL PROBABLY SURPRISE YOU.

**MOTORCYCLES MAKE UP LESS THAN 2% OF ALL REGISTERED VEHICLES AND ONLY 0.4% OF ALL VEHICLE MILES TRAVELED, BUT MOTORCYCLISTS ACCOUNT FOR OVER 9% OF TOTAL TRAFFIC FATALITIES. (NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRATION, OR NHTSA, 2005)**

HOW MANY OF THAT 9% WERE HIT BY CARS THAT DID NOT SEE THEM? HOW MANY WERE HIT BY TEENYBOPPERS TEXTING OR TALKING ON THEIR PHONES? NOW, FOR THE REAL QUESTION...HOW MANY OF THOSE 9% OF ACCIDENTS WOULD HAVE BEEN AVOIDED IF THE RIDER WAS WEARING A HELMET???.....NONE OF THEM!!!

IT SEEMS THAT MOTORCYCLE AWARENESS AND ACCIDENT AVOIDANCE WOULD BE THE FIRST PRIORITIES IN THIS ARGUMENT. LETS GET THE TEENAGERS TO STOP TEXTING WHILE DRIVING AND THE "LEGALLY BLIND" TO RENEW THEIR LICENSES WITH A PRESCRIPTION CHECK EVERY SIX MONTHS AND THE DRUNK DRIVERS TO SPEND A LITTLE MORE THAN ONE NIGHT BEHIND BARS AND THE BUSINESS MEN AND WOMEN TO LOOK UP FROM THEIR PHONES AND LAPTOPS ONCE IN A WHILE TO AVOID HITTING A MOTORCYCLE OR EVEN A SCHOOL BUS, FIRST! I AM PUTTING IT ON OUR LEGISLATIVE SITE UNDER NEW PRESS RELEASES SO ALL CAN ACCESS. HERE IS THE RELEASE. IT IS GOOD FOR SOME IDEAS IN YOUR OWN PERSONAL WRITING CAMPAIGN.

### HELMET USE IS NOT THE PROBLEM IN FLORIDA...

DELAND, FL, NOVEMBER 18, 2010 – MOTORCYCLISTS HAVE FINALLY MADE THE TEN MOST WANTED LIST. NOT BY THE FBI, BUT BY THE NTSB, THE NATIONAL TRANSPORTATION SAFETY BOARD. THE NTSB IS NOW CALLING FOR ALL STATES TO ADOPT A MANDATORY HELMET LAW, EVEN THOUGH ALL CURRENT DATA SUGGESTS THAT THE WEARING OF A HELMET IS NOT AS MAJOR A DETERMINING STATISTIC ON SAVING MOTORCYCLISTS' LIVES AS ONCE THOUGHT.

IN 2000, ABATE OF FLORIDA, INC. SUCCESSFULLY LOBBIED TO HAVE THE MANDATORY HELMET LAW IN FLORIDA REPEALED. ALTHOUGH MANY HAVE PUBLICLY CRIED OUT SAYING THAT MOTORCYCLE DEATHS HAVE BEEN ON THE RISE EVER SINCE THE HELMET REPEAL, THE GOVERNMENT'S OWN STATISTICS SIMPLY DO NOT SUPPORT THIS CLAIM.

ACCORDING TO FLORIDA'S DEPARTMENT OF HIGHWAY SAFETY & MOTOR VEHICLES' REPORT *TRAFFIC SAFETY FACTS, OCTOBER 2010: MOTORCYCLES*, SINCE 2000 MOTORCYCLE REGISTRATIONS HAVE RISEN BY OVER 102%. WITH TWO EXCEPTIONS,

EACH YEAR SINCE THEN MOTORCYCLE REGISTRATIONS AND RELATED FATALITIES HAVE BEEN ON THE INCREASE, BUT WITHIN 1% OF EACH OTHER WHEN COMPARED SIDE-BY-SIDE. ALTHOUGH ANY DEATH IS NEVER GOOD NEWS, STATISTICALLY SPEAKING THIS CAN BE READ TO MEAN THAT THE RISE IN THE REPORTED FATALITIES MAY BE ATTRIBUTED TO THE RISE IN MOTORCYCLE REGISTRATIONS. ONE OF THE REPORTED EXCEPTIONS IS THE YEAR 2009, WHERE MOTORCYCLE REGISTRATIONS INCREASED 102.4% SINCE 2001, BUT FATALITIES ONLY INCREASED 63.4% IN THE SAME TIME FRAME. THAT SAME YEAR, MOTORCYCLE FATALITIES WERE DOWN 16% NATIONWIDE AND OVER 25% IN FLORIDA SINCE THE PREVIOUS YEAR. IN ADDITION, THE FLORIDA DHSMV's *TRAFFIC CRASH STATISTICS REPORT 2009* REPORTED THAT IN 2009, **OVER 53% OF ALL MOTORCYCLISTS KILLED WERE WEARING A HELMET.**

WITH THE ABOVE FACTS, THERE IS NO LOGIC FOR A PUSH TO REQUIRE HELMET USE. THE TEN-YEAR RISE IN DEATHS CAN BE DIRECTLY ATTRIBUTED TO THE RISE IN MOTORCYCLE REGISTRATIONS. SINCE 2004, THE STATE OF FLORIDA HAS REPORTED THAT THE MAJORITY OF MOTORCYCLE DRIVERS AND PASSENGERS IN FATAL CRASHES HAVE BEEN WEARING THE OPTIONAL SAFETY HELMET. ALTHOUGH MOTORCYCLE HELMETS MAY OFFER LIMITED DEFENSIVE MEASURES WHEN INVOLVED IN A HEAD-TRAUMA ACCIDENT, THESE NUMBERS STRONGLY SUGGEST THAT A HELMET IS NOT THE MAGIC SAFETY DEVICE MANY WANT THEM TO BE.

ABATE OF FLORIDA, INC. ASKS LEGISLATORS TO CONSIDER THIS FACT: IN FLORIDA 61% OF THE MOTOR VEHICLE VS. MOTORCYCLE COLLISIONS WERE THE FAULT OF THE MOTOR VEHICLE. THE MOST COMMON REASON GIVEN BY THE VEHICLE DRIVER WAS THAT THEY NEVER SAW THE MOTORCYCLE. TEXTING WHILE DRIVING, HANDS ON THE CELL PHONE INSTEAD OF THE STEERING WHEEL, AND ALMOST INSIGNIFICANT PUNISHMENTS WHEN HITTING A MOTORCYCLIST ARE ALL THE REAL REASONS WHY MOTORCYCLISTS IN FLORIDA ARE BEING KILLED.

FLORIDA NOW REQUIRES A MOTORCYCLE TRAINING PROGRAM TO RECEIVE A MOTORCYCLE ENDORSEMENT ON A DRIVER'S LICENSE. THE MOTORCYCLISTS ARE BEING TRAINED TO RIDE SAFELY AND DEFENSIVELY. HELMETS WILL NOT SAVE MORE MOTORCYCLISTS; EDUCATING THE MOTORING PUBLIC ABOUT THE PRESENCE OF BIKES ON THE ROAD AND STRONGER MOTIVATIONS TO DRIVE A CAR OR TRUCK SAFELY AND LEGALLY SHOULD BE THE DIRECTION STATE AND FEDERAL CONGRESSES TAKE. THE NUMBERS ARE CLEAR; MOST MOTORCYCLISTS ARE DOING THEIR PART. IT'S NOW TIME FOR THE REST OF THE MOTORING PUBLIC TO DO THEIRS.



IN AN OPERATION THAT INVOLVES UNPRECEDENTED INTELLIGENCE COOPERATION BETWEEN OUR COUNTRIES, BRITISH OFFICIALS PROCEED TO UNRAVEL THE PLOT. ON THE NIGHT OF AUG. 9, 2006 THEY LAUNCH A SERIES OF RAIDS IN A NORTHEAST LONDON SUBURB THAT LEAD TO THE ARREST OF TWO DOZEN AL QAEDA TERRORIST SUSPECTS. THEY FIND A USB THUMB-DRIVE IN THE POCKET OF ONE OF THE MEN WITH SECURITY DETAILS FOR HEATHROW AIRPORT, AND INFORMATION ON SEVEN TRANS-ATLANTIC FLIGHTS THAT WERE SCHEDULED TO TAKE OFF WITHIN HOURS OF EACH OTHER:

- \* UNITED AIRLINES FLIGHT 931 TO SAN FRANCISCO DEPARTING AT 2:15 P.M.
- \* AIR CANADA FLIGHT 849 TO TORONTO DEPARTING AT 3:00 P.M.
- \* AIR CANADA FLIGHT 865 TO MONTREAL DEPARTING AT 3:15 P.M.
- \* UNITED AIRLINES FLIGHT 959 TO CHICAGO DEPARTING AT 3:40 P.M.
- \* UNITED AIRLINES FLIGHT 925 TO WASHINGTON DEPARTING AT 4:20 P.M.
- \* AMERICAN AIRLINES FLIGHT 131 TO NEW YORK DEPARTING AT 4:35 P.M.
- \* AMERICAN AIRLINES FLIGHT 91 TO CHICAGO DEPARTING AT 4:50 P.M.

THEY SEIZE BOMB-MAKING EQUIPMENT AND HYDROGEN PEROXIDE TO MAKE LIQUID EXPLOSIVES. AND THEY FIND THE CHILLING MARTYRDOM VIDEOS THE SUICIDE BOMBERS HAD PREPARED.

TODAY, IF YOU ASKED AN AVERAGE PERSON ON THE STREET WHAT THEY KNOW ABOUT THE 2006 AIRLINES PLOT, MOST WOULD NOT BE ABLE TO TELL YOU MUCH. FEW AMERICANS ARE AWARE OF THE FACT THAT AL QAEDA HAD PLANNED TO MARK THE FIFTH ANNIVERSARY OF

9/11 WITH AN ATTACK OF SIMILAR SCOPE AND MAGNITUDE.

AND STILL FEWER REALIZE THAT THE TERRORISTS' TRUE INTENTIONS IN THIS PLOT WERE UNCOVERED THANKS TO CRITICAL INFORMATION OBTAINED THROUGH THE INTERROGATION OF THE MAN WHO CONCEIVED IT: KHALID SHEIKH MOHAMMED.

THIS IS ONLY ONE OF THE MANY ATTACKS STOPPED WITH THE HELP OF THE CIA INTERROGATION PROGRAM ESTABLISHED BY THE BUSH ADMINISTRATION IN THE WAKE OF THE SEPT. 11, 2001, TERRORIST ATTACKS.

UNTIL THE PROGRAM WAS TEMPORARILY SUSPENDED IN 2006, INTELLIGENCE OFFICIALS SAY, WELL OVER HALF OF THE INFORMATION OUR GOVERNMENT HAD ABOUT AL QAEDA-HOW IT OPERATES, HOW IT MOVES MONEY, HOW IT COMMUNICATES, HOW IT RECRUITS OPERATIVES, HOW IT PICKS TARGETS, HOW IT PLANS AND CARRIES OUT ATTACKS-CAME FROM THE INTERROGATION OF TERRORISTS IN CIA CUSTODY.

FORMER CIA DIRECTOR GEORGE TENET HAS DECLARED: "I KNOW THAT THIS PROGRAM HAS SAVED LIVES. I KNOW WE'VE DISRUPTED PLOTS. I KNOW THIS PROGRAM ALONE IS WORTH MORE THAN WHAT THE FBI, THE CENTRAL INTELLIGENCE AGENCY, AND THE NATIONAL SECURITY AGENCY PUT TOGETHER HAVE BEEN ABLE TO TELL US."

FORMER CIA DIRECTOR MIKE HAYDEN HAS SAID: "THE FACTS OF THE CASE ARE THAT THE USE OF THESE TECHNIQUES AGAINST THESE TERRORISTS MADE US SAFER. IT REALLY DID WORK."

EVEN BARACK OBAMA'S DIRECTOR OF NATIONAL INTELLIGENCE, DENNIS BLAIR, HAS ACKNOWLEDGED: "HIGH-VALUE INFORMATION CAME FROM INTERROGATIONS IN WHICH THOSE METHODS WERE USED AND PROVIDED A DEEPER UNDERSTANDING OF THE AL QAEDA ORGANIZATION THAT WAS ATTACKING THIS COUNTRY."

LEON PANETTA, OBAMA'S CIA DIRECTOR, HAS SAID: "IMPORTANT INFORMATION WAS GATHERED FROM THESE DETAINEES. IT PROVIDED INFORMATION THAT WAS ACTED UPON."

AND JOHN BRENNAN, OBAMA'S HOMELAND SECURITY ADVISOR, WHEN ASKED IN AN INTERVIEW IF ENHANCED-INTERROGATION TECHNIQUES WERE NECESSARY TO KEEP AMERICA SAFE, REPLIED : "WOULD THE U.S. BE HANDICAPPED IF THE CIA WAS NOT, IN FACT, ABLE TO CARRY OUT THESE TYPES OF DETENTION AND DEBRIEFING ACTIVITIES? I WOULD SAY YES."

ON JAN. 22, 2009, PRESIDENT OBAMA ISSUED EXECUTIVE ORDER 13491, CLOSING THE CIA PROGRAM AND DIRECTING THAT, HENCEFORTH, ALL INTERROGATIONS BY U.S.

PERSONNEL MUST FOLLOW THE TECHNIQUES CONTAINED IN THE ARMY FIELD MANUAL.

THE MORNING OF THE ANNOUNCEMENT, MIKE HAYDEN WAS STILL IN HIS POST AS CIA DIRECTOR, HE CALLED WHITE HOUSE COUNSEL GREG CRAIG AND TOLD HIM BLUNTY:

"YOU DIDN'T ASK, BUT THIS IS THE CIA OFFICIALLY NONCONCURRING". THE PRESIDENT WENT AHEAD ANYWAY, OVERRULING THE OBJECTIONS OF THE AGENCY.

A FEW MONTHS LATER, ON APRIL 16, 2009, PRESIDENT OBAMA ORDERED THE RELEASE OF FOUR JUSTICE DEPARTMENT MEMOS THAT DESCRIBED IN DETAIL THE TECHNIQUES USED TO INTERROGATE KSM AND OTHER HIGH-VALUE TERRORISTS. THIS TIME, NOT JUST HAYDEN (WHO WAS NOW RETIRED) BUT FIVE CIA DIRECTORS —INCLUDING OBAMA'S OWN DIRECTOR, LEON PANETTA — OBJECTED. GEORGE TENET CALLED TO URGE AGAINST THE MEMOS' RELEASE. SO DID PORTER GOSS. SO DID JOHN EUTCH. HAYDEN SAYS: "YOU HAD CIA DIRECTORS IN A CONTINUOUS UNBROKEN STREAM TO 1995 CALLING SAYING, 'DON'T DO THIS.'"

IN ADDITION TO OBJECTIONS FROM THE MEN WHO LED THE AGENCY FOR A COLLECTIVE 14 YEARS, THE PRESIDENT ALSO HEARD OBJECTIONS FROM THE AGENCY'S COVERT FIELD OPERATIVES. A FEW WEEKS EARLIER, PANETTA HAD ARRANGED FOR THE EIGHT TOP OFFICIALS OF THE CLANDESTINE SERVICE TO MEET WITH THE PRESIDENT. IT WAS HIGHLY UNUSUAL FOR THESE CLANDESTINE OFFICERS TO VISIT THE OVAL OFFICE, AND THEY USED THE OPPORTUNITY TO WARN THE PRESIDENT THAT RELEASING THE MEMOS WOULD PUT AGENCY OPERATIVES AT RISK. THE PRESIDENT REPORTEDLY LISTENED RESPECTFULLY—AND THEN IGNORED THEIR ADVICE.

WITH THESE ACTIONS, BARACK OBAMA ARGUABLY DID MORE DAMAGE TO AMERICA'S NATIONAL SECURITY IN HIS FIRST 100 DAYS OF OFFICE THAN ANY PRESIDENT IN AMERICAN HISTORY.




