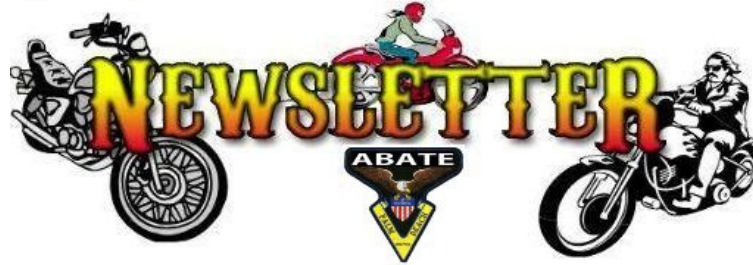

Truck driver charged in the deaths of 7 motorcycle riders in NH found not guilty on all charges

A truck driver charged in the deaths of seven motorcycle riders in New Hampshire was found not guilty on all charges Tuesday.

Volodymyr Zhukovskyy, 26, faced multiple counts of negligent homicide and manslaughter in connection with a crash on Route 2 in Randolph, New Hampshire, on June 21, 2019.

Jurors got the case just before noon, after more than two weeks of testimony and quickly returned the verdict shortly before 3:00 p.m.

Zhukovskyy could be seen pointing to the sky and breaking down in tears after all of the verdicts were read.

Prosecutors had argued that Zhukovskyy, who had taken heroin, fentanyl and cocaine that day, repeatedly swerved back and forth before the head-on crash and told police he caused it. But a judge dismissed eight charges related to whether he was impaired, and his attorney had blamed the lead biker, Albert "Woody" Mazza, saying he lost control of his motorcycle and collided with the truck while driving drunk.

"Obviously we're disappointed," said Assistant Attorney General Scott Chase outside of court. "We believed, looking at the facts, that they were sufficient to prove these charges beyond a reasonable doubt. Our hearts obviously break for the victims' families as well as just the greater community but again we respect the jury's verdict."

The defense team did not speak with reporters after the verdict.

Earlier in the day, during closing arguments, Chase told jurors there was no doubt who caused the deadly collision.

"What happened here isn't a mystery," said Chase.

"It's just as obvious today as it was one three years ago," said Chase, "Since day one, since moment one, every single eyewitness including the man with the front row seat told you exactly what happened - who caused this crash, who was driving recklessly."

"This isn't a mystery. It's not a whodunit," said Chase. "We have heard a lot of excuses; we have heard a lot of distractions. but it is clear what happened here and who caused this crash."

Zhukovskyy's defense blamed the crash on Al Mazza, who was part of the Jarheads Motorcycle Club traveling that day, saying Mazza led his club into one of the worst accidents in recent memory.

"He was drunk, he was not looking where he was going, he lost control of his motorcycle and he slid into the front of Vlad Zhukovskyy's truck," said defense attorney Jay Duguay. "Al Mazza caused this accident."

"Vlad Zhukovskyy is not guilty," said Duguay. "Al Mazza was driving his motorcycle while drunk, he wasn't looking where he was going, he lost control of his bike and slid into the oncoming truck."

Prosecutors addressed the defense tactic of placing the blame on Mazza, who was among the seven killed in the collision.

“Not one person saw Al Mazza impaired, driving off the road, but every person on that road - except for Adam Bartley three cars back - every person on that road saw the defendant all over it.” said Chase. “He endangered everyone.”

The motorcyclists who died were members of the Jarheads Motorcycle Club from New Hampshire, Massachusetts and Rhode Island and ranged in age from 42 to 62. They were part of a larger group that had just left a motel along the highway and were headed to an American Legion Post in Gorham for a fundraiser.

Killed were Mazza, of Lee, New Hampshire; Edward and Jo-Ann Corr, a couple from Lakeville, Massachusetts; Michael Ferazzi, of Contoocook, New Hampshire; Desma Oakes, of Concord, New Hampshire; Daniel Pereira, of Riverside, Rhode Island; and Aaron Perry, of Farmington, New Hampshire.

New Hampshire Governor Chris Sununu released a statement Tuesday, calling the verdict a “absolute tragedy.”

“The Fallen Seven did not receive justice today, and that is an absolute tragedy,” said Sununu. “I share in the shock, outrage, and anger that so many have expressed in the three years since the seven members of the Jarheads Motorcycle Club were taken from us. My heart goes out to their families, friends, and loved ones on this especially dark day.”

Governor, AG stand by reactions to motorcycle crash verdict

Defense lawyers are denouncing comments made by New Hampshire Gov. Chris Sununu and his attorney general after a jury acquitted a truck driver in the deaths of seven motorcyclists, but both men said Wednesday they stand by their statements.

After a two-week trial, jurors deliberated for less than three hours Tuesday before finding Volodymyr Zhukovskyy, 26, innocent on seven counts of manslaughter, seven counts of negligent homicide and one count of reckless conduct. The charges stemmed from a June 21, 2019, crash in Randolph that killed seven members of the Jarheads Motorcycle Club from New Hampshire, Massachusetts and Rhode Island.

Prosecutors argued that Zhukovskyy — who had taken heroin, fentanyl and cocaine earlier on the day of the crash — repeatedly swerved back and forth before the collision and told police he caused it. But a judge dismissed eight charges related to whether he was impaired, and his attorneys blamed the lead biker, Albert “Woody” Mazza Jr., saying he was drunk and not looking where he was going when he lost control of his motorcycle and slid in front of Zhukovskyy’s truck.

And for us with older eyes, can be zoomed in without magnifying glasses. We do need our advertisers, donations and more members to be able print and distribute more copies to the county for motorcyclists to be aware of the issues facing us. Non-members can buy a subscription for \$20 a year but the other two methods are faster as it takes more time and cost to get mailings done.

Attorney General John Formella said he believes the state proved its case.

“Mr. Zhukovskyy should have been found guilty of the charges in this case and held responsible for causing seven deaths and numerous injuries,” he said. “We thank the Court and the jurors for their service, and while we are extremely disappointed, we respect the verdict and our system of justice.”

The New Hampshire Association of Criminal Defense lawyers said Formella’s comments violated professional standards and that both statements criticizing the verdict could deter future jury service.

According to those rules, prosecutors should avoid comments that criticize the jury’s actions or verdict and should “respectfully accept acquittals.” Formella’s spokesman, Michael Garrity, pointed to the last sentence of the attorney general’s statement when asked to respond to the defense lawyers, while Sununu’s spokesman said the governor stands by his comments.

But the defense lawyers said their comments could cause problems for future trials.

“Must our jurors fear public excoriation by the governor and chief law enforcement officer if they find (as jurors did here) that the State failed to meet its burden?” they said. “That our Governor would so loudly put his thumb on the scale is an abuse of his platform and his office. Agree or disagree, the jury here did its job and their decision deserves respect rather than public condemnation.”

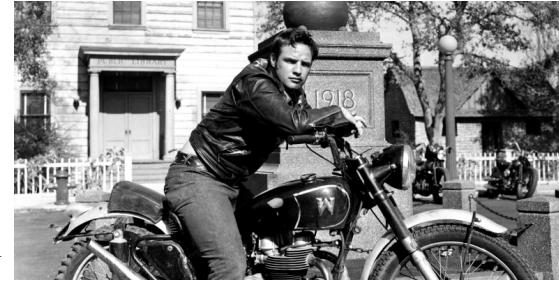


THE DANGERS OF THE OPEN ROAD: 5 KEY WORKS OF MOTORCYCLE NOIR

Seven decades of mayhem, outlaws, and high drama

Over the past century of American culture, the motorcycle has proven troublesomely iconic. A two-wheeled symbol of the open road and Independence? Of course. But the image of the motorcycle is also tightly bound with criminality and mayhem—it's the vehicle of vagabonds, gangs, and others intent on undermining the nation's moral order.



This seedy reputation isn't wholly undeserved. The Justice Department has spent the past several decades pursuing motorcycle gangs such as the Hells Angels, which they consider organized crime syndicates involved in everything from drug trafficking to prostitution. (The lawlessness hasn't curbed the widespread fascination with motorcycle outlaw culture, of course: the people who ride around on motorcycles while dressed as gang members almost certainly outnumber the actual motorcycle gang members in this country.)

The American fascination with the motorcycle and motorcycle gangs has produced an interesting (and diverse) collection of crime fiction films and books over the years. In many of them, motorcyclists are fundamentally misunderstood, hated because they refuse to conform to conservative ideas of morality; in others, they're stand-ins for larger issues of criminality, fatherhood, and fate; and sometimes, they're just straight-up villains.

What Started It All: 'The Wild One' (1953)

One of the movies that made young Marlon Brando into an icon, "The Wild One" centers on the Black Rebels Motorcycle Club (BRMC) riding into a small California town for a race—and igniting tensions between the local citizenry and the leather-clad bikers. A rival gang appears and chaos erupts, climaxing in a death. Although controversial at the time—and banned outright in Britain for 14 years on the grounds of "unbridled hooliganism"—it's tame by modern standards. That said, it's well worth watching for Brando, whose outfit and insouciant attitude toward all kinds of authority no doubt inspired thousands of juvenile delinquents:

Its merits as a film aside, the success of "The Wild One" unleashed a subgenre of outlaw-motorcycle films, most of which were low-budget B-flicks, and some of which featured famous actors before they broke big, such as Jack Nicholson and Bruce Dern. As with so many genres, it then mated with other genres such as horror, giving us questionable gems like "Psychomania" (1971) and "Chopper Chicks in Zombietown" (1989).

Road Hogs with a Literary Bent: 'Tapping the Source' (1984)

Kem Nunn's California crime-fiction masterpiece is largely considered a "surf noir" novel, and with good reason: surfing not only drives the plot, but also the novel's spiritual underpinnings.

Every time the characters enter the ocean with their boards, they seem to commune with the universe—and transcend the grittiness of their lives onshore. But motorcycles, and the protagonist’s ability to repair them, also feature prominently in the plot; they’re just as much as symbol of the characters’ outlaw nature as the drugs, fighting, and surfing.

Outlaw as Daddy Figure: ‘Blood Father’ (2005)

A nasty, sleek novel of parental redemption through gunfire and explosions (made into a nasty, sleek movie in 2018), “Blood Father,” by Peter Craig, centers on John Link. Once a very bad dude—in the book’s opening pages, he tells a story to his AA group about crashing his motorcycle at high speeds on the Pacific Coast Highway, spilling meth everywhere—Link is trying to stay clean and sober: “A man who once flew through traffic on a rebuilt ’56 Harley 74 with a suicide shift, power-jumped with hot-cams, now pattered down main street in a Chevy Nova.”

When his estranged daughter shows up in serious trouble, though, gray-bearded link must revert to his old ways. By the book’s final pages, he’s become a violent trickster, so calm in the middle of a gunfight that he’s almost robotic. In doing so, he achieves a measure of redemption—the motorcycle outlaw made good.

Motorcycle Gang as Gritty Shakespeare: ‘Sons of Anarchy’

On paper, it’s one of those concepts that make television executives salivate uncontrollably: A fast-paced crime series about a California motorcycle club, the Sons of Anarchy, that sells guns—a conceit overlaid with a family drama with unsubtle allusions to “Hamlet” and “Macbeth.”

Amidst seven seasons’ worth of leather-clad motorcycle-gang members growling about loyalty and club laws, there’s an interesting thematic tension at work. Jax Teller (Charlie Hunnam), the son of the club’s founder, is seemingly fated to one day take over as the club’s president; while he’s loyal to the club, he’s also disquieted by the backstabbing among its members and the escalating violence necessary for it to endure. The ultimate tragedy is that, despite his efforts, his loyalty and legacy will drive him to commit some of the most heinous acts imaginable. Like Brando in “The Wild One,” he’s operatically conflicted.

Motorcycle Gang as Pure Evil: ‘101’ (2018)

Tom Pitts’s novel takes place in California on the verge of pot legalization. Up in the wilds of Humboldt County, the weed growers are still doing great business—including Vic Thomas, a grower with a long history of lawbreaking. However, his quiet life is upturned when an old flame’s son shows up, dragging his girlfriend and a lot of stolen money from the Russian mob. A motorcycle gang named the Dead BBs and an angry cop make the ensuing ruckus even more violent and complicated.

Because make no mistake about it: the Dead BBs are bad. “Not just an outlaw, but a fucking criminal,” a character muses at one point. It’s a fun, breezy ride, a bit of gritty California noir that moves at exceptional speed—with motorcycle outlaws you love to hate. <https://crimereads.com/the-dangers-of-the-open-road-5-key-works-of-motorcycle-noir/>

‘One Fast Move’: Maia Reficco, Edward James Olmos & Austin North Board Motorcycle Racing Pic From Gulfstream Pictures And Lubert Roklin

Weekly Roundup: DeSantis Prosecutes War on 'Woke' By Ryan Dailey

TALLAHASSEE — About six hours after he was suspended Thursday by Gov. Ron DeSantis, Andrew Warren insisted he was still Hillsborough County's top prosecutor — and that the governor was trying to “overthrow” democracy.

“I'm still doing this job as state attorney. I'm the twice duly elected state attorney of Hillsborough County. And the governor signing something with a pen or a crayon doesn't change that,” Warren, a Democrat, said of DeSantis' order.

DeSantis announced Thursday morning that he was replacing Warren with Hillsborough County Judge Susan Lopez, But that didn't stop Warren from going ahead with an afternoon press conference to announce new developments in two grisly 1983 crimes — separate rape and murder cases, one that went unsolved and another that initially resulted in a wrongful conviction.

It wasn't Warren's work on those cases that drew the governor's ire. As DeSantis wages a scorched-earth campaign against all things he deems “woke,” the governor targeted Warren over his professed refusal to enforce a new law preventing abortions after 15 weeks of pregnancy.

“The conduct that he has done has fell below the standard that's required in the Florida Constitution. When you're saying you're not going to enforce certain laws you don't like, that's a neglect of duty,” DeSantis said.

The Legislature passed the 15-week abortion law during this year's legislative session, and DeSantis signed it in April. Providers could face third-degree felony charges for breaking the law.

Warren recently signed a joint letter along with more than 90 other prosecutors from across the country promising to avoid prosecuting people for providing or seeking abortions. The letter was published in June by the organization Fair and Just Prosecution, which bills itself as bringing together elected local prosecutors to promote “a justice system grounded in fairness, equity, compassion and fiscal responsibility.”

During his Tampa appearance to announce Warren's suspension, the governor invited law-enforcement officials from the Tampa Bay area to pile on. Former Tampa Police Chief Brian Dugan, who retired last year, called Warren a “fraud” and criticized Warren for not prosecuting 67 Tampa protesters who were arrested during demonstrations after the death of George Floyd in 2020 in Minneapolis.

Warren also signed a separate letter last year “condemning the criminalization of transgender people and gender-affirming healthcare,” which also was published by Fair and Just Prosecution.

“That's a debate that we're having mostly administratively and through medical licensing in Florida. But other states have enacted penalties on the people who would perform those, which are really disfiguring these young kids. And (Warren) said it doesn't matter what the Legislature does in the state of Florida, he's going to exercise a veto over that,” DeSantis said Thursday.

DeSantis said he will pursue Warren's eventual removal from the 13th Judicial Circuit post, which would need approval from a Republican-controlled state Senate that has time and again delivered on DeSantis' requests.

Warren on Thursday said he has "a feeling" that DeSantis' order suspending him "is going to be just as unconstitutional" as the 15-week abortion law.

"The governor's trying to overthrow the results of a fair and free election. Two of them, actually. And people need to understand, this isn't the governor trying to suspend one elected official. This is the governor trying to overthrow democracy here in Hillsborough County," Warren said.

CIRCLING BACK Two years after justices thwarted his first attempt to place Renatha Francis on the Florida Supreme Court, DeSantis on Friday tapped the Palm Beach County circuit judge to serve on a high court dominated by conservative jurists.

Francis' initial appointment in 2020 was ultimately overturned because Francis hadn't reached a 10-year Bar membership requirement for justices.

Francis, who was among six finalists sent to DeSantis by the Florida Supreme Court Judicial Nominating Commission this summer, will replace outgoing Justice Alan Lawson, who will retire from the bench on Aug. 31.

DeSantis said Francis will join the Supreme Court in early September. He billed her as understanding what the "proper role of the judge is" under America's constitutional system. She will be the first Jamaican-American justice.

"And I also think being an immigrant, she probably has more appreciation for our constitutional system," the governor said, noting Francis attended law school after starting her own business. "I believe this appointment of Judge Francis is one that will really reinvigorate and fortify our judiciary in a very positive way but also send a great message that you can realize your dreams."

Francis, who called herself the "epitome of the American dream," echoed DeSantis' judicial philosophy during a Friday news conference.

"As a student of history, I was and I remain in awe of the United States Constitution," she said. "The Florida Supreme Court protects the people's liberty, and inherent in the way that we do that is by respecting and observing the limited role that judges play in our constitutional system of government."

With four of the seven-member court's justices appointed by DeSantis, the Republican governor will leave his Federalist Society imprint on the Supreme Court for decades to come.

OPIOID CZAR TAPPED A first-of-its-kind role in Florida's state government will oversee a "massive" effort to address opioid addiction in counties that need it most.

Courtney Phillips, a psychologist who is director of behavioral health for the Health Care District of Palm Beach County, will serve in the newly created role of statewide director of opioid recovery.

Phillips will oversee a new program called the Coordinated Opioid Recovery, or CORE, Network, which was announced by state leaders Wednesday. The network is

based on a pilot treatment program in Palm Beach County that state health officials touted as a success.

The program's rollout came after nearly 2,000 overdose deaths in Florida this year.

Public and private organizations will work together in treatment networks, officials said. The organizations will team up to provide emergency services, then patients will be stabilized at specialty hospitals and finally transferred to long-term care facilities.

The program will start in Brevard, Clay, Escambia, Gulf, Marion, Pasco and Volusia counties. A second phase will include Citrus, Duval, Flagler, Manatee and Pinellas counties.
